33	(a) A person awarded a	state contract of fifty	thousand dollars
34	(\$50,000) or more shall file a	a report under this secti	ion with the Secretary
35	of State.		
36	(b) The report shall in	aclude:	

1	(1) An itemization, including without limitation the recipient,		
2	of political contributions that, in the aggregate, exceed fifty dollars		
3	(\$50.00) made by:		
4	(A) The person;		
5	(B) An employee of the person; and		
6	(C) A business entity in which the person has a common		
7	ownership interest of fifty percent (50%) or more; and		
8	(2) The total amount of political contributions made by the		
9	person.		
10	(c)(l)(A) The report shall be filed annually no earlier than January 1		
11	and no later than January 31 of each year.		
12	(B) The annual report under subdivision (c)(1)(A) of this		
13	section shall contain the information under subdivision (b)(1) of this		
14	section for the preceding calendar year.		
15	(2)(A) In addition to the annual report under subdivision (c)(1)		
16	of this section, a person shall file a report no later than thirty (30) days		
17	after the award of a state contract.		
18	(B) A report filed no later than thirty (30) days after		
19	the award of a state contract shall contain the information under subdivision		
20	(b)(l) of this section for:		
21	(i) The calendar year that the state contract is		
22	awarded; and		
23	(ii) The calendar year preceding the year that the		
24	state contract is awarded.		
25	(d)(1) A person with more than one (1) state contract may file a		
26	single annual report representing each of the person's state contracts.		
27	(2) However, a person shall file a report no later than thirty		
28	(30) days after the award of a state contract regardless of whether the		
29	person has more than one (1) state contract.		
30	(3) A person filing an annual report under this section shall		
31	report information under subdivision (b)(1) of this section only from the		
32	date of execution of the contract if:		
33	(A) The person was awarded the state contract in the
