18	WHEREAS, families and businesses throughout the State of Arkansas
19	operate under the principle of a balanced budget; and

21	WHEREAS, the State of Arkansas itself maintains a balanced budget, a
22	practice that has spared Arkansas from the financial problems seen in other
23 24	states in recent years; and
25	WHEREAS, the government of the United States of America does not
26	operate under a balanced budget, which is evidenced by a ballooning federal
27	public debt; and

29	WHEREAS, continued deficit spending demonstrates an unwillingness or
30	inability of both the federal executive and legislative branches to spend no
31	more than available revenues; and

33	WHEREAS, fiscal irresponsibility at the federal level is lowering our
34	standard of living, destroying jobs, and endangering economic opportunity now
35	and for the next generation; and

1	WHEREAS, Article 5 of the United States Constitution allows Congress to
2	propose amendments to the United States Constitution to the states for
3	ratification and also allows the legislatures of the several states to
4	request a convention for the purpose of proposing amendments,
5	
6	NOW THEREFORE, BE IT RESOLVED BY THE SENATE OF THE EIGHTY-EIGHTH GENERAL
7	ASSEMBLY, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:
8	
9	THAT the Arkansas Congressional Delegation propose and support efforts
10	for the Congress of the United States to pass and propose to the legislatures
11	of the several States, for ratification, an amendment to the Constitution of
12	the United States requiring in the absence of a national emergency that the
13	total of all federal appropriations made by the Congress for any fiscal year
14	may not exceed the total of all estimated federal revenues for that fiscal
15	year.
16	
17	BE IT FURTHER RESOLVED that if such an amendment is not proposed by the
18	Congress, that the Arkansas Congressional Delegation support the calling of a
19	constitutional convention by the legislatures of the several states for the
20	purpose of proposing a balanced budget amendment to the United States
21	Constitution.

23	BE IT FURTHER RESOLVED that, upon passage, the Chief Clerk of the
24	Senate shall transmit a copy of this resolution to all members of the
25	Arkansas Congressional Delegation.
