16	WHEREAS, the Human Resources profession plays a critical and strategic
17	role in the overall daily operations of an employer and an employer's
18	workforce; and

20	WHEREAS, the Human Resources professional assists an employer in
21	recruiting, hiring, training, evaluating, and managing an employer's
22	workforce; and
23	
24	WHEREAS, the Human Resources professional addresses compliance issues
25	for an employer on federal, state, and local laws; and
26	
27	WHEREAS, many human resources professionals are members of the Arkansas
28	council of the Society for Human Resources Management State Council, Inc.
29	("ARSHRM") which is affiliated with the national Society for Human Resource
30	Management ("SHRM"), the world's largest professional association devoted to
31	human resource management, and serves eight (8) Arkansas SHRM chapters which
32	serve over two thousand (2,000) Arkansas members of SHRM and human resources
33	professionals; and

35	WHEREAS, ARSHRM and local SHRM chapters' missions are to serve the
36	needs of Human Resources professionals by providing the most current and

1	comprehensive resources, and to advance the profession by promoting Human
2	Resources' essential, strategic role; and
3	
4	WHEREAS, ARSHRM and local SHRM chapters make available to employers and
5	human resources professionals in Arkansas up-to-date information on pending
6	legislation that may affect an Arkansas employer's operations and the
7	Arkansas workforce; and
8	
9	WHEREAS, ARSHRM and local SHRM chapters, through their members and
10	volunteers, have assisted over the past years in supplying knowledge and
11	resources to state legislators, state committees, and state agencies on how
12	to address legislation related to employers or how the impact of legislation
13	affects an employer and the workforce in Arkansas; and

15	WHEREAS, ARSHRM provides an annual human resources conference in April
16	to educate and inform the Human Resource profession in Arkansas on current
17	and comprehensive resources and topics affecting the Human Resource
18	professional's role in the workplace and is celebrating its 25^{th} Anniversary
19	in the year 2011; and

21	WHEREAS, ARSHRM provides an annual employment law and legislative
22	affairs conference in September to educate and inform employers and the Human
23	Resource profession in Arkansas on recent changes in laws and regulations
