18	BE IT ENACTED BY THE	GENERAL ASSEMBLY OF THE STATE OF ARKANSA	AS:

20	SECTION 1. REAP	PROPRIATION - NORTHWEST TECHNICAL INSTIT	TUTE. There is
21	hereby appropriated, to the Northwest Technical Institute, to be payable from		
22	the General Improvement Fund or its successor fund or fund accounts, for the		
23	Northwest Technical I	nstitute the following:	
24	(A) For the bal	ance of the appropriation provided in It	cem (F) Section 1
25	of Act 87 of 2011 and	Item (A) Section 4 of Act 86 of 2011, 1	for transfers of
26	or refunds to expendi	tures for capital balances for construct	ion, renovation,
27	major maintenance, an	d purchase of equipment for various capi	ital projects or
28	facility improvements	, in a sum not to exceed	\$105,829.

30	SECTION 2. DISB	URSEMENT CONTROLS. (A) No contract may	be awarded nor
31	obligations otherwise	incurred in relation to the project or	projects
32	described herein in e	xcess of the State Treasury funds actual	lly available
33	therefor as provided	by law. Provided, however, that institu	itions and
34	agencies listed herei	n shall have the authority to accept and	l use grants and
35	donations including F	ederal funds, and to use its unobligated	l cash income or
36	funds, or both availa	ble to it, for the purpose of supplement	ing the State

Treasury funds for financing the entire costs of the project or projects
enumerated herein. Provided further, that the appropriations and funds
otherwise provided by the General Assembly for Maintenance and General
Operations of the agency or institutions receiving appropriation herein shall
not be used for any of the purposes as appropriated in this act.

6 (B) The restrictions of any applicable provisions of the State 7 Purchasing Law, the General Accounting and Budgetary Procedures Law, the 8 Revenue Stabilization Law and any other applicable fiscal control laws of 9 this State and regulations promulgated by the Department of Finance and 10 Administration, as authorized by law, shall be strictly complied with in 11 disbursement of any funds provided by this act unless specifically provided 12 otherwise by law.

14 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 15 Assembly that any funds disbursed under the authority of the appropriations 16 contained in this act shall be in compliance with the stated reasons for 17 which this act was adopted, as evidenced by the Agency Requests, Executive 18 Recommendations and Legislative Recommendations contained in the budget 19 manuals prepared by the Department of Finance and Administration, letters, or 20 summarized oral testimony in the official minutes of the Arkansas Legislative 21 Council or Joint Budget Committee which relate to its passage and adoption. 22

23 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 24 Assembly, that the Constitution of the State of Arkansas prohibits the 25 appropriation of funds for more than a one (1) year period; that the 26 effectiveness of this Act on the date of its passage and approval is 27 essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative 28 session, the delay in the effective date of this Act beyond the date of its 29 30 passage and approval could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, 31 32 an emergency is hereby declared to exist and this Act being necessary for the 33 immediate preservation of the public peace, health and safety shall be in 34 full force and effect from and after the date of its passage and approval. 35
