5	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of	of funds

12	the Department of Finance and Administration, as authorized by law, shall be		
13	strictly complied with in disbursement of said funds.

15	SECTION 3. LEGISLATIVE INTENT. It is the intent of the	ne General	
16	Assembly that any funds disbursed under the authority of the	e appropriations	
17	contained in this act shall be in compliance with the stated reasons for		
18	which this act was adopted, as evidenced by the Agency Requests, Executive		
19	Recommendations and Legislative Recommendations contained in the budget		
20	manuals prepared by the Department of Finance and Administration, letters, o		
21	summarized oral testimony in the official minutes of the Arkansas Legislativ		
22	Council or Joint Budget Committee which relate to its passage	ge and adoption.

24	SECTION 4. EMERGENCY CLAUSE. It is found and determin	ned by the General	
25	Assembly, that the Constitution of the State of Arkansas pro	ohibits the	
26	appropriation of funds for more than a one (1) year period; that the		
27	effectiveness of this Act on July 1, 2012 is essential to the	ne operation of	
28	the agency for which the appropriations in this Act are provided, and that i		
29	the event of an extension of the legislative session, the delay in the		
30	effective date of this Act beyond July 1, 2012 could work in	rreparable harm	
31	upon the proper administration and provision of essential governmental		
32	programs. Therefore, an emergency is hereby declared to exist and this Act		
33	being necessary for the immediate preservation of the public peace, health		
34	and safety shall be in full force and effect from and after	July 1, 2012.
