1 SECTION 40. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LANDFILL 3 POST-CLOSURE CLEAN UP RESTRICTIONS. Any expenditures in excess of \$50,000 4 per site from the Landfill Post-Closure Trust Fund, as appropriated in 5 Section 20, Item (04) for corrective action to remedy environmental impacts 6 of closed disposal sites previously operated as a landfill pursuant to state 7 law will be prioritized and authorized by the Commission after addressing 8 corrective actions needed to address environmental impacts from permitted 9 landfills closed properly. The total of the said expenditures shall not 10 exceed \$2,000,000 per fiscal year.

12 SECTION 41. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NON 14 HAZARDOUS SITE CLEAN UP RESTRICTIONS. Expenditures from the Arkansas 15 Department of Environmental Quality Fee Trust Fund for the cleanup of non 16 hazardous sites which pose a threat to the environment, as appropriated in 17 Section 32, shall be funded only through interest earnings from the Arkansas 18 Department of Environmental Quality Fee Trust Fund. The Arkansas Department 19 of Environmental Quality shall seek cost recovery from parties responsible 20 for damages to the environment that dictate the use of appropriation 21 authorized in Section 32 of this act, as well as, any other funds spent by a 22 governmental entity to remediate such non hazardous sites.

24 SECTION 42. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 26 FAYETTEVILLE SHALE QUARTERLY REPORTING. The Arkansas Department of 27 Environmental Quality shall report on a quarterly basis to the Arkansas 28 Legislative Council or the Joint Budget Committee the number of inspections, any hearings, findings, orders, fines, or other agency regulatory or 29 30 enforcement actions or activities involving the Fayetteville Shale. The 31 quarterly reports shall be provided no later than the 15th day of the month 32 immediately following the end of each quarter.

33 The provisions of this section shall be in effect only from July 1, 34 2011 2012 through June 30, 2012 2013.

10 SECTION 44. LEGISLATIVE INTENT. It is the intent of the General 11 Assembly that any funds disbursed under the authority of the appropriations 12 contained in this act shall be in compliance with the stated reasons for 13 which this act was adopted, as evidenced by the Agency Requests, Executive 14 Recommendations and Legislative Recommendations contained in the budget 15 manuals prepared by the Department of Finance and Administration, letters, or 16 summarized oral testimony in the official minutes of the Arkansas Legislative 17 Council or Joint Budget Committee which relate to its passage and adoption. 18

19 SECTION 45. EMERGENCY CLAUSE. It is found and determined by the 20 General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the 21 22 effectiveness of this Act on July 1, 2012 is essential to the operation of 23 the agency for which the appropriations in this Act are provided, and that in 24 the event of an extension of the legislative session, the delay in the 25 effective date of this Act beyond July 1, 2012 could work irreparable harm 26 upon the proper administration and provision of essential governmental 27 programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health 28 29 and safety shall be in full force and effect from and after July 1, 2012. 30 31 32 33 34
