20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Health Services Permit Agency for the 2012-2013 fiscal year, the following
24 maximum number of regular employees.

36 SECTION 4. APPROPRIATION - DEVELOPMENTAL DISABILITIES PLANNING COUNCIL

1 - FEDERAL. There is hereby appropriated, to the Health Services Permit
 2 Agency, to be payable from the federal funds as designated by the Chief
 3 Fiscal Officer of the State, for personal services and operating expenses of
 4 the Health Services Permit Agency – Developmental Disabilities Planning
 5 Council – Federal for the fiscal year ending June 30, 2013, the following:

 20 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 22 FORWARD. Any unexpended balance of funds generated by fees and fines pursuant
 23 to Arkansas Code 20-8-103 et. seq. deposited into the Miscellaneous Agencies
 24 Fund Account which remain at the close of each state fiscal year shall be
 25 carried forward to the next state fiscal year to be used for the same intent
 26 and purposes as set forth in law.

27 Any carry forward of unexpended balance funding as authorized herein, may
 28 be carried forward under the following conditions:

29 (1) Prior to June 30, ~~2010~~ 2013 the Agency shall by written statement set
 30 forth its reason(s) for the need to carry forward said funding to the
 31 Department of Finance and Administration Office of Budget;

32 (2) The Department of Finance and Administration Office of Budget shall
 33 report to the Arkansas Legislative Council all amounts carried forward by the
 34 September Arkansas Legislative Council or Joint Budget Committee meeting,
 35 which report shall include the name of the Agency, Board, Commission or
 36 Institution and the amount of the funding carried forward, the program name

1 or line item, the funding source of that appropriation and a copy of the
2 written request set forth in (1) above;

3 (3) Each Agency, Board, Commission or Institution shall provide a written
4 report to the Arkansas Legislative Council or Joint Budget Committee
5 containing all information set forth in item (2) above, along with a written
6 statement as to the current status of the project, contract, purpose etc. for
7 which the carry forward was originally requested no later than thirty (30)
8 days prior to the time the Agency, Board, Commission or Institution presents
9 its budget request to the Arkansas Legislative Council/Joint Budget
10 Committee; and

11 (4) Thereupon, the Department of Finance and Administration shall include
12 all information obtained in item (3) above in the budget manuals and/or a
13 statement of non-compliance by the Agency, Board, Commission or Institution.

14 The provisions of this section shall be in effect only from July 1, ~~2010~~
15 2012 through June 30, ~~2011~~ 2013.

16
17 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
18 authorized by this act shall be limited to the appropriation for such agency
19 and funds made available by law for the support of such appropriations; and
20 the restrictions of the State Procurement Law, the General Accounting and
21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
22 Procedures and Restrictions Act, or their successors, and other fiscal
23 control laws of this State, where applicable, and regulations promulgated by
24 the Department of Finance and Administration, as authorized by law, shall be
25 strictly complied with in disbursement of said funds.

26
27 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
28 Assembly that any funds disbursed under the authority of the appropriations
29 contained in this act shall be in compliance with the stated reasons for
30 which this act was adopted, as evidenced by the Agency Requests, Executive
31 Recommendations and Legislative Recommendations contained in the budget
32 manuals prepared by the Department of Finance and Administration, letters, or
33 summarized oral testimony in the official minutes of the Arkansas Legislative
34 Council or Joint Budget Committee which relate to its passage and adoption.

35
36 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General

1 Assembly, that the Constitution of the State of Arkansas prohibits the
2 appropriation of funds for more than a one (1) year period; that the
3 effectiveness of this Act on July 1, 2012 is essential to the operation of
4 the agency for which the appropriations in this Act are provided, and that in
5 the event of an extension of the legislative session, the delay in the
6 effective date of this Act beyond July 1, 2012 could work irreparable harm
7 upon the proper administration and provision of essential governmental
8 programs. Therefore, an emergency is hereby declared to exist and this Act
9 being necessary for the immediate preservation of the public peace, health
10 and safety shall be in full force and effect from and after July 1, 2012.
