## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
SERVICES AND OPERATING EXPENSES OF THE ROOSEVELT  
ROAD BARRACKS TO THE DEPARTMENT OF CORRECTION  
WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO  
THOSE FUNDS APPROPRIATED BY ACT 1114 OF 2011; AND  
FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE DEPARTMENT OF CORRECTION -  
ROOSEVELT ROAD BARRACKS SUPPLEMENTAL  
APPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the  
Department of Correction for the 2011-2012 fiscal year, the following maximum  
number of regular employees which shall be supplemental and in addition to  
those positions authorized in Section 1 of Act 1114 of 2011.

SECTION 2. APPROPRIATION - INMATE CARE & CUSTODY. There is hereby appropriated, to the Department of Correction, to be payable from the Department of Correction Inmate Care and Custody Fund Account, for personal services and operating expenses of the Department of Correction which shall be supplemental and in addition to those funds appropriated in Section 3 of Act 1114 of 2011, the following:

SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal Officer of the State shall transfer on his or her books and those of the State Treasurer and the Auditor of the State the sum of one million four hundred ten thousand eight hundred twenty-six dollars (\$1,410,826) from the unobligated funds in the General Improvement Fund to the Inmate Care and Custody Fund Account to provide funds for personal services and operating expenses of the Department of Correction - Inmate Care & Custody to establish and operate an inmate housing facility located on Roosevelt Road.

SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. The funds transferred under the provisions of Section 3 of this Act shall be carried forward and made available for the same purposes for the

1 fiscal year ending June 30, 2013.

3 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
4 authorized by this act shall be limited to the appropriation for such agency  
5 and funds made available by law for the support of such appropriations; and  
6 the restrictions of the State Procurement Law, the General Accounting and  
7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
8 Procedures and Restrictions Act, or their successors, and other fiscal  
9 control laws of this State, where applicable, and regulations promulgated by  
10 the Department of Finance and Administration, as authorized by law, shall be  
11 strictly complied with in disbursement of said funds.

13 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General  
14 Assembly that any funds disbursed under the authority of the appropriations  
15 contained in this act shall be in compliance with the stated reasons for  
16 which this act was adopted, as evidenced by the Agency Requests, Executive  
17 Recommendations and Legislative Recommendations contained in the budget  
18 manuals prepared by the Department of Finance and Administration, letters, or  
19 summarized oral testimony in the official minutes of the Arkansas Legislative  
20 Council or Joint Budget Committee which relate to its passage and adoption.

22 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
23 Assembly, that funds provided by the General Assembly for the operations of  
24 the Department of Correction are, due to unforeseen circumstances,  
25 insufficient for the Department of Correction to continue to provide  
26 essential governmental services; that the provisions of this act will provide  
27 the necessary monies for the Department of Correction to continue such  
28 services; and that a delay in the effective date of this Act could work  
29 irreparable harm upon the proper administration and provision of essential  
30 governmental programs. Therefore, an emergency is hereby declared to exist  
31 and this Act being necessary for the immediate preservation of the public  
32 peace, health and safety shall be in full force and effect from and after the  
33 date of its passage and approval.

34 If the bill is neither approved nor vetoed by the Governor, it shall  
35 become effective on the expiration of the period of time during which the  
36 Governor may veto the bill. If the bill is vetoed by the Governor and the

veto is overridden, it shall become effective on the date the last house  
overrides the veto.
