21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the  
24 Arkansas State Game and Fish Commission for the 2012-2013 fiscal year, the  
25 following maximum number of regular employees.

8 SECTION 2. EXTRA HELP. There is hereby authorized, for the Arkansas  
 9 State Game and Fish Commission for the 2012-2013 fiscal year, the following  
 10 maximum number of part-time or temporary employees, to be known as "Extra  
 11 Help", payable from funds appropriated herein for such purposes: one hundred  
 12 eighty-five (185) temporary or part-time employees, when needed, at rates of  
 13 pay not to exceed those provided in the Uniform Classification and  
 14 Compensation Act, or its successor, or this act for the appropriate  
 15 classification.

17 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 18 to the Arkansas State Game and Fish Commission, to be payable from the Game  
 19 Protection Fund, for personal services, operating expenses, acquisition,  
 20 maintenance and improvements of the Arkansas State Game and Fish Commission  
 21 for the fiscal year ending June 30, 2013, the following:

SECTION 4. APPROPRIATION - GAS LEASE REVENUES. There is hereby appropriated, to the Arkansas State Game and Fish Commission, to be payable from the Game Protection Fund, for operating expenses, capital projects, acquisition of land and conservation easements of the Arkansas State Game and Fish Commission for the fiscal year ending June 30, 2013, the following:

SECTION 5. APPROPRIATION. CONSERVATION PARTNERS PROGRAM GRANTS. There is hereby appropriated, to the Arkansas State Game and Fish Commission, to be payable from the Game Protection Fund, the following:

(A) for grants to conservation partners, or other eligible entities for operating, equipment, and maintenance expenses associated with addressing statewide hunger needs, in a sum not to exceed.....\$100,000.

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUNTERS FEEDING THE HUNGRY. Arkansas Hunters Feeding the Hungry is designed to share the harvest of an abundant resource with Arkansans' who are in need of food, partner with the Game and Fish Commission in order to provide a solution for a healthy, balanced deer herd, provide a much needed free, low fat, high protein food source to the many feeding agencies and organizations across Arkansas and create a provider purpose for hunters who participate, allowing them to give back and share with others. In order to help sustain the Arkansas Hunters Feeding the Hungry program in Arkansas the Arkansas Game and Fish Commission may establish a check off or other appropriate methods to raise revenue for support of the program. The intent of this Section is to

1 encourage the Arkansas Game and Fish Commission to examine opportunities  
2 available to provide support for the Arkansas Hunters Feeding the Hungry  
3 program.

4 The provisions of this section shall be in effect only from July 1,  
5 2012 through June 30, 2013.

6  
7 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PAYMENT  
9 OF REWARDS. Payment of rewards shall be from the Game Protection Fund from  
10 the Commission's Maintenance and General Operation appropriation as herein  
11 appropriated in Section 3, Item No. (05)(A).

12 The provisions of this section shall be in effect only from July 1,  
13 ~~2010~~2012 through June 30, ~~2011~~2013.

14  
15 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA  
17 HELP RESTRICTION. No employee of the Arkansas Game and Fish Commission who is  
18 employed as extra help may receive an amount to exceed eighty-five percent  
19 (85%) of the maximum annual salary for a comparable position as authorized  
20 under § 21-5-201 et seq. during any fiscal year, nor shall such an employee  
21 be employed for a period of time to exceed one thousand eight hundred (1,800)  
22 hours in any single fiscal year.

23  
24 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General  
25 Assembly that any funds disbursed under the authority of the appropriations  
26 contained in this act shall be in compliance with the stated reasons for  
27 which this act was adopted, as evidenced by the Agency Requests, Executive  
28 Recommendations and Legislative Recommendations contained in the budget  
29 manuals prepared by the Department of Finance and Administration, letters, or  
30 summarized oral testimony in the official minutes of the Arkansas Legislative  
31 Council or Joint Budget Committee which relate to its passage and adoption.

32  
33 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the  
34 General Assembly, that the Constitution of the State of Arkansas prohibits  
35 the appropriation of funds for more than a one (1) year period; that the  
36 effectiveness of this Act on July 1, 2012 is essential to the operation of

1 the agency for which the appropriations in this Act are provided, and that in  
2 the event of an extension of the legislative session, the delay in the  
3 effective date of this Act beyond July 1, 2012 could work irreparable harm  
4 upon the proper administration and provision of essential governmental  
5 programs. Therefore, an emergency is hereby declared to exist and this Act  
6 being necessary for the immediate preservation of the public peace, health  
7 and safety shall be in full force and effect from and after July 1, 2012.
