7	SECTION 3. LEGISLATIVE INTENT. It is the intent of the General		
8	Assembly that any funds disbursed under the authority of the appropriations		
9	contained in this act shall be in compliance with the stated reasons for		
10	which this act was adopted, as evidenced by the Agency Requests, Executive		
11	Recommendations and Legislative Recommendations contained in the budget		
12	manuals prepared by the Department of Finance and Administration, letters, o		
13	summarized oral testimony in the official minutes of the Arkansas Legislative		
14	Council or Joint Budget Committee which relate to its passage and adoption.		
15			
16	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General		
17	Assembly, that the Constitution of the State of Arkansas prohibits the		
18	appropriation of funds for more than a one (1) year period; that the		
19	effectiveness of this Act on July 1, 2012, with the exception that Section 2		
20	in this Act shall be in full force and effect from and after the date of its		
21	passage and approval, is essential to the operation of the agency for which		
22	the appropriations in this Act are provided, and that in the event of an		
23	extension of the legislative session, the delay in the effective date of thi		
24	Act beyond July 1, 2012, with the exception that Section 2 in this Act shall		
25	be in full force and effect from and after the date of its passage and		
26	approval, could work irreparable harm upon the proper administration and		
27	provision of essential governmental programs. Therefore, an emergency is		
28	hereby declared to exist and this Act being necessary for the immediate		
29	preservation of the public peace, health and safety shall be in full force		
30	and effect from and after July 1, 2012, with the exception that Section 2 in		
31	this Act shall be in full force and effect from and after the date of its		
32	passage and approval.
