SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS HEALTH CENTER. (A) The Department of Human Services shall not close the Arkansas Health Center that provides skilled nursing through specialized services and programs.

- 32 (B) The Department of Human Services shall continue to accept clients for 33 whom it has determined that skilled nursing and specialized services are 34 needed at the Arkansas Health Center.

14 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ACUTE 16 MENTAL HEALTH SERVICES - PER CAPITA - LEGISLATIVE FINDINGS AND INTENT. The 17 General Assembly recognizes that the state encouraged the treatment of 18 mentally ill residents within community-based settings over two decades ago 19 and has taken various approaches to funding since then. The General Assembly 20 also recognizes that there are inherent problems within the current public 21 mental health system that create disincentives for proper treatment and care. 22 The purpose of the Acute Mental Health Services - Per Capita appropriation is 23 to provide an appropriation for acute mental health services to be utilized 24 within community-based settings for the treatment and care of medically 25 indigent persons 18 years of age and older and involuntary commitments to the 26 public mental health system. The appropriation for acute mental health 27 services provided in this Act shall only be used for Community Mental Health 28 Centers licensed and certified by the Division of Behavioral Health of the 29 Department of Human Services for use within community-based settings and 30 facilities.

SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BEHAVIORAL HEALTH SERVICES - PROCEEDS FOR SALES OF TIMBER AND HAY - CAPITAL 35 IMPROVEMENTS AND EQUIPMENT. The Division of Behavioral Health Services is authorized to use administrative operating account for capital improvements

- 1 to the physical plant, and for the purchase of capital equipment, and for the
- 2 operation of the Arkansas Health Center, operated by the Department of Human

17	the appropriation of funds for more than a one (1) year period; that the
18	effectiveness of this Act on July 1, 2012 is essential to the operation of
19	the agency for which the appropriations in this Act are provided, and that in
20	the event of an extension of the legislative session, the delay in the
21	effective date of this Act beyond July 1, 2012 could work irreparable harm
22	upon the proper administration and provision of essential governmental
23	programs. Therefore, an emergency is hereby declared to exist and this Act
24	being necessary for the immediate preservation of the public peace, health
25	and safety shall be in full force and effect from and after July 1, 2012.
