12 JUNE 30, 2013; AND FOR OTHER PURPOSES.

15 AN ACT FOR THE DEPARTMENT OF HUMAN SERVICES  
16 - DIVISION OF STATE SERVICES FOR THE BLIND

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
25 for the Department of Human Services - Division of State Services for the  
26 Blind for the 2012-2013 fiscal year, the following maximum number of regular  
27 employees.

20 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for  
 21 the Department of Human Services - Division of State Services for the Blind  
 22 for the 2012-2013 fiscal year, the following maximum number of part-time or  
 23 temporary employees, to be known as "Extra Help", payable from funds  
 24 appropriated herein for such purposes: fourteen (14) temporary or part-time  
 25 employees, when needed, at rates of pay not to exceed those provided in the  
 26 Uniform Classification and Compensation Act, or its successor, or this act  
 27 for the appropriate classification.

29 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 30 to the Department of Human Services - Division of State Services for the  
 31 Blind, to be payable from the paying account as determined by the Chief  
 32 Fiscal Officer of the State, for personal services and operating expenses of  
 33 the Department of Human Services - Division of State Services for the Blind  
 34 for the fiscal year ending June 30, 2013, the following:

14       SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 15 authorized by this act shall be limited to the appropriation for such agency  
 16 and funds made available by law for the support of such appropriations; and  
 17 the restrictions of the State Procurement Law, the General Accounting and  
 18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 19 Procedures and Restrictions Act, or their successors, and other fiscal  
 20 control laws of this State, where applicable, and regulations promulgated by  
 21 the Department of Finance and Administration, as authorized by law, shall be  
 22 strictly complied with in disbursement of said funds.

24       SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
 25 Assembly that any funds disbursed under the authority of the appropriations  
 26 contained in this act shall be in compliance with the stated reasons for  
 27 which this act was adopted, as evidenced by the Agency Requests, Executive  
 28 Recommendations and Legislative Recommendations contained in the budget  
 29 manuals prepared by the Department of Finance and Administration, letters, or  
 30 summarized oral testimony in the official minutes of the Arkansas Legislative  
 31 Council or Joint Budget Committee which relate to its passage and adoption.

33       SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
 34 Assembly, that the Constitution of the State of Arkansas prohibits the  
 35 appropriation of funds for more than a one (1) year period; that the  
 36 effectiveness of this Act on July 1, 2012 is essential to the operation of

1 the agency for which the appropriations in this Act are provided, and that in  
2 the event of an extension of the legislative session, the delay in the  
3 effective date of this Act beyond July 1, 2012 could work irreparable harm  
4 upon the proper administration and provision of essential governmental  
5 programs. Therefore, an emergency is hereby declared to exist and this Act  
6 being necessary for the immediate preservation of the public peace, health  
7 and safety shall be in full force and effect from and after July 1, 2012.
