BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16 SECTION 46. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
18 HELP PROVISION. No employee of the Arkansas Forestry Commission who is
19 employed as "Extra Help" may receive an amount to exceed 3/4 of the maximum
20 annual salary for a comparable position as authorized by Arkansas Code 21-5-
21 201 et seq. during any fiscal year, nor may such employee be employed for a
22 period of time to exceed nine (9) months in any single fiscal year.
23 Provided, however, that no employee of the Arkansas Forestry Commission who
24 is employed as "Extra Help" may receive an amount to exceed seventy five
25 percent (75%) of the maximum annual salary for a comparable position as
26 authorized by Arkansas Code 21-5-201 et seq. during any fiscal year, nor
27 shall such employee be employed for a period of time to exceed fourteen
28 hundred (1400) hours in any single fiscal year.

29 The provisions of this section shall be in effect only from July 1,
30 ~~2010~~ 2012 through June 30, ~~2011~~ 2013.

31
32 SECTION 47. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
34 PROVISION. If the State Forestry Commission determines that temporary
35 firefighters, dispatchers, or pilots are required to meet the demands of a
36 wildfire season, and upon approval of the Chief Fiscal Officer of the State,

1 appropriations may be transferred from either Extra Help or Professional Fees
2 and Services to the proper character code for the employment of such
3 personnel.

4 If the State Forestry Commission determines that the deployment of air
5 tankers for fighting wildfires requires additional Professional Fees and
6 Services, and upon the approval of the Chief Fiscal Officer of the State,
7 excess appropriation in Regular Salaries or Personal Services Matching may be
8 transferred to Professional Fees and Services in Section 3 and 30.

9 If the State Forestry Commission determines that the most effective way for
10 it to cooperate in the growing and distribution of forest planting stock is
11 by contracting work with private vendors and/or hiring temporary employees
12 for seasonal work, the Commission is hereby authorized, upon approval by the
13 Chief Fiscal Officer of the State, to transfer the necessary appropriation
14 authorized for Extra Help and Maintenance and General Operation in Section 3
15 and 30.

16 The provisions of this section shall be in effect only from July 1,
17 ~~2010~~ 2012 through June 30, ~~2011~~ 2013.

18
19 SECTION 48. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO
21 EXPENDITURE. The Arkansas Forestry Commission is authorized to charge fees
22 to federal agencies and other states to reimburse the Commission for
23 expenditures made on behalf of these governmental units. These fees shall be
24 deposited into the State Forestry Fund in the State Treasury as a refund to
25 expenditure.

26 The provisions of this section shall be in effect only from July 1, ~~2010~~
27 2012 through June 30, ~~2011~~ 2013.

28
29 SECTION 49. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

31 ALLOCATION RESTRICTIONS. The Secretary of the Arkansas Department of
32 Agriculture shall at no time designate general revenue allocations to the
33 State Plant Board, the Arkansas Livestock and Poultry Commission and the
34 Arkansas Forestry Commission at a level less than the revenue distribution
35 provided in the Official Forecast of state general revenue in effect for each
36 of those agencies.

1 The provisions of this section shall be in effect only from July 1, 2010
2 2012 through June 30, ~~2011~~ 2013.

3
4 SECTION 50. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REPORTING
6 REQUIREMENTS. The Arkansas Forestry Commission shall present the following
7 data each month to the Chief Fiscal Officer of the State and the Arkansas
8 Legislative Council or Joint Budget Committee. This report shall be due by
9 the 10th day of the month following the reporting period. The first reporting
10 period shall be July 2012.

- 11 a) All fund transfers completed by the Arkansas Forestry Commission
12 from any funding source including federal funds, and shall include
13 a justification for the completion of the fund transfers.
14 b) All expenditures incurred by the Arkansas Forestry Commission from
15 any funding source including federal funds, and shall include a
16 justification for the expenditure of the funds.
17 c) All revenue receipts of the Arkansas Forestry Commission including
18 but not limited to federal funds, general revenue, severance tax,
19 acreage tax, timber sales and seedlings sales.
20 d) All Arkansas Forestry Commission activities including but not
21 limited to, firefighting activities, fire prevention, and
22 emergency response as it relates to the Commission's statutory
23 mission provided in Arkansas Code 15-31-101.

24 The provisions of this section shall be in effect only from July 1,
25 2012 through June 30, 2013.
26

27 SECTION 51. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
28 authorized by this act shall be limited to the appropriation for such agency
29 and funds made available by law for the support of such appropriations; and
30 the restrictions of the State Procurement Law, the General Accounting and
31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
32 Procedures and Restrictions Act, or their successors, and other fiscal
33 control laws of this State, where applicable, and regulations promulgated by
34 the Department of Finance and Administration, as authorized by law, shall be
35 strictly complied with in disbursement of said funds.
36

1 SECTION 52. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this act shall be in compliance with the stated reasons for
4 which this act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.

9
10 SECTION 53. EMERGENCY CLAUSE. It is found and determined by the
11 General Assembly, that the Constitution of the State of Arkansas prohibits
12 the appropriation of funds for more than a one (1) year period; that the
13 effectiveness of this Act on July 1, 2012 is essential to the operation of
14 the agency for which the appropriations in this Act are provided, and that in
15 the event of an extension of the legislative session, the delay in the
16 effective date of this Act beyond July 1, 2012 could work irreparable harm
17 upon the proper administration and provision of essential governmental
18 programs. Therefore, an emergency is hereby declared to exist and this Act
19 being necessary for the immediate preservation of the public peace, health
20 and safety shall be in full force and effect from and after July 1, 2012.
