13	be entirely focused upon and exclusively limited to the subject matter of				
14	proposing for ratification an amendment to the Constitution providing that an				
15	increase in the federal debt require approval from a majority of the

18	THAT this application constitutes a continuing application in				
19	accordance with Article V of the Constitution of the United States until at				
20	least two-thirds (2/3) of the legislatures of the several states have made				
21	application for an equivalently limited amendments convention.
