3	BE IT RESOLVED BY THE SENATE OF THE EIGHTY-EIGHTH GENERAL ASSEMBLY OF THE

6	THAT, as provided for in Article V of the Constitution of the United			
7	States, the General Assembly of the State of Arkansas herewith respectfully			
8	apply for an amendments convention to be called for the purpose of proposing			
9	an amendment which shall provide that an increase in the federal debt requir			
10	approval from a majority of the legislatures of the separate states,			
11				
12	THAT the amendments convention contemplated by this application shall			
13	be entirely focused upon and exclusively limited to the subject matter of			
14	proposing for ratification an amendment to the Constitution providing that as			
15	increase in the federal debt require approval from a majority of the			
16	legislatures of the separate states, and			
17				
18	THAT this application constitutes a continuing application in			
19	accordance with Article V of the Constitution of the United States until at			
20	least two-thirds ($2/3$) of the legislatures of the several states have made			
21	application for an equivalently limited amendments convention.

23	BE IT FURTHER RESOLVED THAT a certified copy of this application be			
24	dispatched by the Secretary of State of Arkansas to the President of the			
25	United States Senate, to the Speaker of the United States House of			
26	Representatives, to each member of Arkansas's delegation to the United States			
27	Congress, and to the presiding officer of each house of the several state			
28	legislatures, requesting their cooperation in applying for the amendments			
29	convention limited to the subject matter contemplated by this application.
