26	BE IT RESOLVED BY THE SENATE OF THE EIGHTY-EIGHTH GENERAL ASSEMBLY OF THE
27	STATE OF ARKANSAS:

29	WHEREAS, the Republic of China (Taiwan) is a full-fledged democracy
30	characterized by stability and social order, and Taiwan is the world's
31	twenty-third largest economy, seventeenth largest exporter, eighteenth
32	largest importer, and the fifth largest holder of foreign exchange reserves,
33	with over \$391 billion; and
34	
35	WHEREAS, the United States and Taiwan engage in robust bilateral trade,
36	and the United States ranks as Taiwan's third largest trading partner, and

1 Taiwan is the ninth largest trading partner of the United States; and 2 3 WHEREAS, on average, 580,000 people from Taiwan visit the United States 4 each year and Taiwan's national carriers, China Airlines and EVA Air, 5 currently each have 23 to 24 flights destined for the United States weekly, 6 carrying more than 5,000 passengers daily for business, tourism, study, 7 observation, friends, and family visits; and 8 9 WHEREAS, Taiwan citizens routinely obtain various visas to the United 10 States and return to Taiwan as scheduled, and Taiwan citizens present few, if 11 any, crime or public security issues while in the United States; and 12 13 WHEREAS, in 2010, the rejection rate of United States visa applications 14 of Taiwan citizens was only 2.2%, well below the 3% requirement for the 15 United States Visa Waiver Program; and 16 17 WHEREAS, Taiwan has extended visa waivers to the United States since 18 1993, and there are more than 100 nations or areas currently granting Taiwan 19 citizens visa waivers, including the European Union, the United Kingdom, 20 Ireland, Japan, New Zealand, Singapore, Canada, and the United States Island 21 Territory of Guam, and 22 23 WHEREAS, Taiwan is recognized as a nation with exemplary economic and 24 environmental progress, including substantial progress in the aviation 25 industry; and 26 27 WHEREAS, great advantages would result in Taiwan's participation in the 28 International Civil Aviation Organization and the United Nations Framework 29 Convention on Climate Change; and 30 31 WHEREAS, Director General Daniel Liao will be making a visit to 32 Arkansas to explore economic development and educational opportunities between Taiwan and Arkansas, 33 34 NOW THEREFORE BE IT RESOLVED BY THE SENATE OF THE EIGHTY-EIGHTH GENERAL 35 36 ASSEMBLY OF THE STATE OF ARKANSAS:

THAT the Arkansas Senate:

(1) Supports Taiwan's participation in the International Civil Aviation Organization and the United Nations Framework Convention on Climate Change; (2) Welcomes Taiwan's nomination to the United States Visa Waiver Program; (3) Urges the United States Department of Homeland Security to facilitate the evaluation of Taiwan's homeland security and security immigration systems to facilitate Taiwan's formal membership to the United States Visa Waiver Program; (4) Continues to encourage the sister-state relationship between Arkansas and Taiwan initially formed in 1983; and (5) Welcomes Director General Daniel Liao during his upcoming visit to Arkansas. BE IT FURTHER RESOLVED THAT upon adoption of this resolution, an appropriate copy shall be provided to Mr. Daniel Liao, Director General of the Taipei Economic and Cultural Office in Houston by the Secretary of the Senate.
