19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code Title 6, Chapter 15, Subchapter 13, is
22 amended to add an additional section to read as follows:

23 6-15-1303. Confidential information.

24 (a) Records or information that have been adopted by a school, a
25 school district, or the State Board of Education and that indicate a policy,
26 procedure, or plan to ensure school security or a safe learning environment
27 for students and school employees shall be treated as confidential and are
28 exempt from public disclosure under the Freedom of Information Act of 1967, §
29 25-19-101 et seq.

30 (b) Meetings or consultations of a school, school district board of
31 directors, or the State Board of Education for the purpose of developing or
32 instituting a policy, procedure, or plan to ensure school security or a safe
33 learning environment for students and school employees shall be treated as
34 confidential and are exempt from public disclosure under the Freedom of
35 Information Act of 1967, § 25-19-101 et seq.

2 SECTION 2. Arkansas Code Title 6, Chapter 60, Subchapter 1, is amended
3 to add an additional section to read as follows:

4 6-60-104. Confidential information.

5 (a) Records or information that have been adopted by a state-supported
6 institution of postsecondary or higher education and that indicate a policy,
7 procedure, or plan to ensure campus security or a safe learning environment
8 for students and school employees shall be treated as confidential and are
9 exempt from public disclosure under the Freedom of Information Act of 1967, §
10 25-19-101 et seq.

11 (b) Meetings or consultations of a state-supported institution of
12 postsecondary or higher education for the purpose of developing or
13 instituting a policy, procedure, or plan to ensure campus security or a safe
14 learning environment for students and school employees shall be treated as
15 confidential and are exempt from public disclosure under the Freedom of
16 Information Act of 1967, § 25-19-101 et seq.
