4	the contract.
5	(b) Before a contract with a community-based provider is modified or
6	amended the division shall:
7	(1) Notify the community-based provider of the proposed
8	modification or amendment at least forty-five (45) days before the contract
9	modification or amendment is executed;
10	(2) Provide the community-based provider an opportunity to
11	comment on the proposed modification or amendment; and
12	(3) File the proposed contract modification or amendment and all
13	community-based provider comments with the Subcommittee on Administrative
14	Rules and Regulations of the Legislative Council at least thirty (30) days
15	before the contract modification or amendment is executed.
