20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 2-16-504(b)(1), concerning elections to
23 establish Johnson Grass Control districts, is amended to read as follows:

24 (b)(1) ~~Immediately upon the submission of~~ If the petition to the
25 ~~county court or courts is submitted under subdivision (a)(1) of this section,~~
26 the court or courts shall issue a proclamation calling the election ~~in~~
27 ~~accordance with~~ under § 7-11-201 et seq. and notify the county board or
28 boards of election commissioners in writing. The election shall be held on a
29 date ~~in accordance with~~ under § 7-11-201 et seq. ~~but in no event more than~~
30 ~~ninety (90) days following publication of the proclamation.~~
31

32 SECTION 2. Arkansas Code § 3-8-302(a), concerning election date by
33 petition regarding wholesale alcohol, is amended to read as follows:

34 (a) ~~Upon application by~~ If a written petition, signed by a number of
35 legal voters in ~~any~~ a county, city, town, district, or precinct to be
36 affected equal to thirty-five percent (35%) of the qualified voters is



1 ~~submitted, it shall be the duty of~~ the judge of the county court in the
 2 county shall at the next regular term ~~thereof,~~ after receiving the petitions,
 3 ~~to make an~~ enter a written order ~~on his or her order book~~ directing an
 4 election to be held in the county, city, town, district, or precinct to be
 5 affected ~~thereby,~~ on ~~some day named in the petition no earlier than sixty~~
 6 ~~(60) days after the application is lodged with the judge of the court~~ a date
 7 authorized under § 7-11-304. However, in counties having two (2) judicial
 8 districts, the legal voters in either district may petition for an election
 9 and the election can only affect the judicial district where the election may
 10 be held.

 12 SECTION 3. Arkansas Code § 6-14-102 is amended to read as follows:

13 6-14-102. Annual school election date – Special school election.

14 (a)~~(1)~~ The annual school election shall be held in each school
 15 *district of the state on the third Tuesday in September.*

16 (2) *The annual school election shall only concern issues*
 17 *authorized to be on the ballot by the Arkansas Constitution or by statute,*
 18 *and no other issues shall appear on the ballot.*

19 (b) The board of directors of ~~any a~~ school district ~~shall have the~~
 20 ~~authority to~~ may hold a school election concerning the tax rate or debt
 21 issues on a date under § 7-11-304 ~~other than that fixed by law~~ provided that:

22 (1) All constitutional and statutory requirements for the annual
 23 school election are met, notwithstanding ~~subdivision~~ subsection (a)~~(1)~~ of
 24 this section;

25 (2) The election is held before the date of the annual school
 26 election; and

27 (3) The Commissioner of Education approves the date of the
 28 election.

 34 ballot, with the exception of the local tax rate if that rate is not being
 35 changed or restructured, the board of directors of ~~any a~~ school district, by
 36 resolution, may request the county board of election commissioners to reduce

1 the number of polling places or to open no polling places on election day so
2 that the election can be conducted by absentee ballot and early voting only.

3 (2)(A) If requested by ~~proper~~ resolution adopted by the board of
4 directors of ~~any a~~ school district, the county board of election
5 commissioners ~~may~~ shall provide that no polling places be open on election
6 day so that the election can be conducted by absentee ballot and early voting
7 only.

8 (B) In a county that uses voting machines or electronic
9 vote tabulating devices, the county board of election commissioners may
10 ~~choose to~~ use paper ballots counted by hand and ~~may provide that~~ use no
11 voting machines ~~shall be used~~ in the election, notwithstanding any other
12 provision in the Arkansas Code.

13
14 SECTION 4. Arkansas Code § 6-53-602(b)(2), concerning publication of
15 proclamation by a community college, is amended to read as follows:

16 (2)(A) The local board or acting local board shall issue a
17 proclamation and set a date for the election under § 7-11-201 et seq., ~~but~~
18 ~~the date set for the election shall not be later than~~

19 (B) The local board or acting local board shall publish
20 the proclamation at least ninety (90) days ~~after the publication of the~~
21 ~~proclamation~~ before the election date.

22
23 SECTION 5. Arkansas Code § 6-53-603(a)(2), concerning the date of
24 election for a tax levy called by a local board of a community college, is
25 amended to read as follows:

26 (2) ~~It~~ The tax may be reduced or repealed, with the exception of
27 the amount of tax required to service ~~any an~~ outstanding ~~bonds~~ bond, or the
28 tax may be increased upon approval ~~thereof~~ by a majority of the qualified

20 SECTION 9. Arkansas Code Title 7, Chapter 11, Subchapter 3, is amended
21 to add an additional section to read as follows:

24 authorized document calling a special election shall:

25 (1) Set the date of the special election; and

26 (2) Be filed at least one hundred twenty (120) days before the
27 date the special election is to be held.

28 (b) If a special election is called in a year in which a preferential
29 primary election or general election is held, the special election shall be
30 held with the preferential primary election or general election.

31 (c) If a special election is called in a year in which a preferential
32 primary election or general election is not held, the special election shall
33 be held on the Tuesday next after the first Monday in May or the Tuesday next
34 after the first Monday in November.

35 (d) This section does not apply to a special election to fill a
36 vacancy in office, a special runoff election, or a special election otherwise

1 provided for by law.

2
3 SECTION 10. Arkansas Code § 11-10-1006(a), concerning elections for
4 Arkansas Unemployment Trust Fund Bonds, is amended to read as follows:

5 (a)(1) Arkansas Unemployment Trust Fund Bonds shall not be issued
6 under this subchapter unless the issuance of bonds has been approved by a
7 majority of the qualified electors of the state voting on the question at a
8 statewide election called by proclamation of the Governor as provided under §
9 11-10-1005.

10 (2)(A) An election under this section may be in conjunction with
11 a general election, or it may be a special election.

12 (B) A special election held under this section shall ~~occur~~

1 SECTION 11. Arkansas Code § 14-14-917(a)(2), concerning special
2 elections for referendum petition measures, is amended to read as follows:

4 measure may be submitted to the electors during a regular general election
5 and shall be submitted if the ~~adequacy of the~~ petition is determined to be
6 adequate within the time limitation prescribed in this section. A referendum
7 measure may also be referred to the electors at a special election called for

19 at a special election by order of the quorum court in accordance with § 7-11-
20 201 et seq.

26 SECTION 23. Arkansas Code § 14-386-403(a), concerning elections on
27 enclosures in fencing districts, is amended to read as follows:

- 17 (B) One-fourth of one percent (0.25%);
- 18 (C) One-half of one percent (0.50%);
- 19 (D) Three-fourths of one percent (0.75%);
- 20 (E) One percent (1%); or
- 21 (F) Any combination of these amounts.

14 (F) Any combination of these amounts.

15 (2) The election shall be held ~~within one hundred twenty (120) days of~~
16 ~~the ordinance calling for the election~~ under § 7-11-201 et seq.

17 (3) Each tax shall be adopted by ordinance and with approval of the
18 voters of the county in accordance with this subchapter.
