19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 12-12-103 is amended to read as follows:

22 12-12-103. Pawnshop records – Penalty.

23 (a) ~~It shall be the duty of each and every~~ A pawnshop ~~and~~ or
24 pawnbroker doing business in the State of Arkansas ~~to~~ shall keep a record
25 showing in detail all property pawned with ~~them~~ the pawnshop or pawnbroker.

26 (b) ~~(1)~~ The records required under subsection (a) of this section shall
27 include:

28 (A) A detailed record of each ~~and every~~ transaction,
29 including the type of identification displayed by the person from whom the
30 property was received;

31 (B) The name, address, race, sex, height, weight, and date
32 of birth of the person from whom the property was received;

33 (C) The driver's license number, personal identification
34 number issued under § 27-16-805, or the number from ~~some other~~ another form
35 of photographic identification of the person from whom the property was
36 received; and



1 (D) A description of each item pawned, including, ~~but not~~
 2 ~~limited to,~~ without limitation:

3 (i) ~~identifying~~ Identifying numbers or serial
 4 numbers; and

5 (ii) The amount paid by the pawnshop or pawnbroker
 6 for the item pawned.

7 ~~(2) The records shall be maintained on the following form:~~

14 (c)(1)(A) One (1) copy of the records required under subsection (a) of
 15 this section shall be maintained on file with the pawnshop or pawnbroker for
 16 a period of three (3) years.

17 (B) The Director of the Department of Arkansas State
 18 Police, ~~any a~~ a member of the Department of Arkansas State Police, ~~any a~~ a county
 19 sheriff or deputy of the county, or ~~any a~~ a police officer of the municipality
 20 in which the pawnshop or pawnbroker is located shall have access to ~~all such~~
 21 the records at any reasonable time.

22 (2) The director, the county sheriff, or the chief of police in
 23 ~~any the~~ the county or municipality in which the pawnshop or pawnbroker is located
 24 may require a report of ~~such~~ transactions for ~~such periods~~ a period of time
 25 ~~as that~~ he or she ~~shall deem~~ deems necessary for the efficient enforcement of
 26 the criminal laws or to aid in criminal investigations.

27 (d)(1) The failure ~~on the part of~~ any a pawnbroker, or an owner, or
 28 operator of a pawnshop to comply with a provision of this section ~~shall be is~~
 29 a violation.

30 ~~(2) Upon conviction the offender shall be punished~~ punishable by
 31 a fine of not more than one thousand dollars (\$1,000).

32 ~~(3)(2)~~ (2) Each day a pawnbroker, or owner, or operator of a
 33 pawnshop fails to comply with ~~a provision of~~ this section ~~shall constitute is~~
 34 a separate offense ~~and shall be punished accordingly.~~

35 (e)(1) ~~Any city or county may require by ordinance that pawnshops~~
 36 Pawnshops and pawnbrokers shall:

1 (A) ~~Submit~~ Keep the records required by this section in a
 2 designated electronic format; and

3 (B) Daily upload ~~data~~ the records in the designated
 4 electronic format to:

5 (i) A centralized secure tracking system and
 6 Internet website designated by the chief law enforcement officer of a county,
 7 city, or local government; and

8 (ii) a A different centralized secure tracking system
 9 and Internet website other than the centralized secure tracking system ~~to be~~
 10 ~~chosen by the city or~~ and Internet website designated under subdivision
 11 (e)(1)(B)(i) of this section if designated by county or municipal ordinance.

12 (2) The electronic records submitted under this subsection (e)
 13 shall be used for the sole purpose of investigating crimes ~~involving~~
 14 ~~property.~~

15 ~~(3)~~ Pawnshops, pawnbrokers, and pawn customers shall not be
 16 required to incur any costs or increased fees as a result of the city, ~~or~~
 17 county, or state collecting and processing records required by this section
 18 electronically.
