## For An Act To Be Entitled

8 AN ACT TO AUTHORIZE SPECIAL LICENSE PLATES FOR THE  
9 LITTLE ROCK AIR FORCE BASE; AND FOR OTHER PURPOSES.  
10

### Subtitle

11 TO AUTHORIZE SPECIAL LICENSE PLATES FOR  
12 THE LITTLE ROCK AIR FORCE BASE.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
18

19 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is  
20 amended to add an additional section to read as follows:

21 27-24-1411. Little Rock Air Force Base.

22 (a) The Director of the Department of Finance and Administration shall  
23 issue a special license plate for the Little Rock Air Force Base in the  
24 manner and subject to the conditions provided for under this subchapter.

25 (b) The special Little Rock Air Force Base motor vehicle license plate  
26 shall be:

27 (1) Designed by the Department of Finance and Administration in  
28 consultation with Air Power Arkansas; and

29 (2) Numbered consecutively.

30 (c) The director shall determine the cost for the issuance of the  
31 special license plate under this section as follows:

32 (1) The fee for the cost of initial orders of the new design,  
33 which shall be based on the cost of the initial order;

34 (2) The number of applications that must be received to cover  
35 the cost of the initial order of the new design; or

36 (3) The combination of subdivisions (c)(1) and (2) of this



1 section that must be received to cover the cost of the initial order of the  
2 new design.

3 (d) The department shall issue a special license plate under this  
4 section upon payment of:

5 (1) The fee required by law for registration of the motor  
6 vehicle;

7 (2)(A) A fee not to exceed twenty-five dollars (\$25.00) for the  
8 design-use contribution by Air Power Arkansas;

9 (B) The department shall remit the fees collected under  
10 this subdivision (d)(2) on a *monthly* basis to Air Power Arkansas;

11 (3) A handling and administrative fee of ten dollars (\$10.00)  
12 that is:

13 (A) Deposited into the State Central Services Fund for the  
14 benefit of the Revenue Division of the Department of Finance and  
15 Administration;

16 (B) Credited to the division as supplemental and in  
17 addition to all other funds deposited for the benefit of the division; and

18 (C) Not considered or credited to the division as direct  
19 revenue.

20 (e)(1) A special license plate issued under this section may be  
21 renewed annually or replaced under the procedures set out in § 27-24-1405.

22 (2) However, the division shall remit the fees collected under §  
23 27-24-1405(b)(2) on a monthly basis to Air Power Arkansas.

25 *SECTION 2. EFFECTIVE DATE. This act is effective on and after January*  
26 *1, 2014.*
