2 SECTION 2. Arkansas Code § 11-9-303(c)(2), resulting from Initiated 3 Act 4 of 1948 and concerning the payment of a tax on all written manual 4 premiums that is additional to the premium taxes collected from carriers, is 5 amended to read as follows:

6 (2) This transfer from the funds created in § 11-9-301 shall be 7 in the same proportions that deposits were made into the three (3) funds as 8 set forth in under § 11-9-306(a)-(c).

10 SECTION 3. Arkansas Code § 11-9-304(a), resulting from Initiated Act 4 11 of 1948 and concerning the payment of the workers' compensation premium tax 12 by a self-insurer, is amended to read as follows:

13 (a) It shall be the duty of the The Workers' Compensation Commission 14 to shall collect a tax from every self-insured employer at a rate to be 15 determined as provided by under § 11-9-306 but not to exceed three percent 16 (3%) four percent (4%) of the written manual premium which that would have to 17 be paid under § 11-9-303 by a carrier if the self-insured employer were 18 insured by a carrier.

20 SECTION 4. Arkansas Code § 11-9-305(a)(1), resulting from Initiated 21 Act 4 of 1948 and concerning the payment of the workers' compensation premium 22 tax by a public employer, is amended to read as follows:

23 (a)(1) It shall be the duty of the The Workers' Compensation 24 Commission to shall collect a tax from every public employer providing 25 workers' compensation coverage to its employees at a rate to be determined as 26 provided by under § 11-9-306 but not to exceed three percent (3%) four 27 percent (4%) of the written manual premium which that an insurance carrier 28 would have to pay under § 11-9-303 if the public employer were insured by a 29 carrier.

SECTION 5. Arkansas Code § 11-9-306(d), resulting from Initiated Act 4 31 32 of 1948 and concerning the determination of a surplus and rate of taxation 33 for the workers' compensation premium tax, is amended to read as follows:

34 (d)(1) The total rate of taxation for all three (3) funds when added 35 together shall not exceed three percent (3%) four percent (4%) of all written 36 manual premiums.
