## For An Act To Be Entitled

8 AN ACT TO CLARIFY AMUSEMENT RIDE AND ATTRACTION  
9 INSPECTION AND INSURANCE REQUIREMENTS FOR RIDES OR  
10 ATTRACTIONS OWNED AND OPERATED BY NONPROFIT,  
11 RELIGIOUS, CHARITABLE, OR FAIR ORGANIZATIONS; AND FOR  
12 OTHER PURPOSES.

15 TO CLARIFY INSPECTION AND INSURANCE  
16 REQUIREMENTS FOR RIDES AND ATTRACTIONS  
17 OWNED AND OPERATED BY NONPROFIT,  
18 RELIGIOUS, CHARITABLE, OR FAIR

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 23-89-503 is amended to read as follows:  
26 23-89-503. Exemptions.

27 The following amusement rides or attractions are exempt from the  
28 provisions of this subchapter:

29 (1) Nonmechanized playground equipment, including, but not  
30 limited to, swings, seesaws, stationary spring-mounted animal features,  
31 rider-propelled merry-go-rounds, climbers, slides, trampolines, swinging  
32 gates, and physical fitness devices except when an admission fee is charged  
33 for usage or an admission fee is charged to immediate areas where the  
34 equipment is located;

35 ~~(2) An amusement ride or amusement attraction which is owned and~~  
36 ~~operated by a nonprofit religious, educational, or charitable institution or~~



1 ~~association, or a fair if the ride or attraction is subject to inspection by~~  
2 ~~the State Fire Marshal or by any political subdivision of the state under its~~  
3 ~~building, fire, electrical, and related public safety ordinances;~~

4           ~~(3)(2)~~ Coin-operated amusement rides or amusement attractions  
5 located on the premises of retail business establishments; and

6           ~~(4)(3)~~ An amusement ride or amusement attraction which is owned  
7 and operated by the State of Arkansas or any political subdivision thereof.
