Arkansas Code § 28-65-104, concerning guardianship for 8 incapacitated persons, is amended to add an additional subdivision to read as 9 follows: 10 (3) Persons under age twenty-one (21) who: 11 (A) Have reached eighteen (18) years of age; 12 (B) Have a current guardianship established based solely 13 on the minority age of the person; 14 (C) Agree to allow the current guardianship to continue up 15 to twenty-one (21) years of age; and 16 (D) Receive a guardianship subsidy paid for or approved by 17 the Department of Human Services. 18 19 SECTION 3. Arkansas Code § 28-65-107(c), concerning the jurisdiction 20 of courts in guardianship cases, is amended to add an additional subdivision 21 to read as follows: 22 (3) The Department of Human Services may intervene as a matter 23 of right in a guardianship action at any time before the entry of a permanent 24 guardianship order if: 25 (A) A guardianship action is initiated for a child or 26 adult in the custody of the department, including a seventy-two-hour hold; 27 and 28 (B) The custody of the child or adult is granted to a 29 party seeking guardianship. 30 SECTION 4. Arkansas Code § 28-65-401(a), concerning the termination of 31 32 guardianship, is amended to add an additional subdivision to read as follows: 33 (4) If the guardianship was solely because of the ward's 34 minority, by the ward reaching the age of majority, unless the guardian 35 receives a guardianship subsidy from the Department of Human Services, then 36 the guardianship is terminated when the ward:
