4	property owned by a nonmember of a volunteer fire department, is amended to

6	(2)(A) A claim for services in responding to a fire involving		
7	only personal property shall be allowed only for personal property of		
8	nonmembers.		
9	(B) The claimed amount under subdivision (b)(2)(A) of this		
10	section shall not exceed eight hundred dollars (\$800) <u>one thousand five</u>		
11	hundred dollars (\$1,500).		
12	(C)(i) A claim under subdivision (b)(2)(A) of this section		
13	shall be supported by a completed and attached Uniform Fire Department
