23	SECTION 1. Arka	ansas Code § 27-24-206(a), concerning	g fees and
24	limitations for milita	ary and veterans' special license pla	ates, is amended to
25	read as follows:

27	(a)(l) Except a	as provided in subdivision (a)(2) of	this section <u>and in</u>
28	§ 27-24-212(e), specia	al license plates created and issued	under this
29	subchapter shall be fr	ree of charge to an eligible applica	nt.

31	SECTION 2. Arka	ansas Code Title 27, Chapter 24, Sub	chapter 2, is
32	amended to add additio	onal sections as follows:	
33	27-24-212. Vete	erans of Foreign Wars.	
34	(a) The purpose	e of this section is to honor the se	rvice of members of
35	the Veterans of Foreig	gn Wars by providing a special licen	se plate that is
36	available for issuance	<u>.</u>	

1	(b) It is found and determined by the General Assembly of the State of		
2	Arkansas that the men and women who have served our country overseas and		
3	risked their lives to secure our freedom should be honored by the issuance of		
4	a free special license plate as provided under this subchapter.		
5	(c) The Department of Finance and Administration is authorized to		
6	issue a Veterans of Foreign Wars special license plate to an applicant who		
7	establishes upon initial application that he or she, by membership card or		
8	Lifetime Member card, is a member of the:		
9	(1) Veterans of Foreign Wars;		
10	(2) Ladies Auxiliary to the Veterans of Foreign Wars;		
11	(3) Men's Auxiliary to the Veterans of Foreign Wars;		
12	(4) Auxiliary to the Veterans of Foreign Wars;		
13	(5) Junior Girls of the Ladies Auxiliary to the Veterans of		
14	Foreign Wars; or		
15	(7) Sons of the VFW.		
16	(d)(1) The department shall design the special license plate issued		
17	under this section in consultation with the Department of Arkansas Veterans		
18	of Foreign Wars.		
19	(2)(A) In place of the legend "The Natural State" at the bottom		
20	of the special license plate, a permanent decal shall be made available for a		
21	veteran of each conflict as authorized under § 27-24-204(9)-(12), (15), and		
22	<u>(16).</u>		
23	(B) Alternatively, at the request of the applicant, in		
24	place of the legend "The Natural State" or any succeeding legend, there shall		
25	be placed across the bottom of the license plate a permanent decal bearing		
26	the words "Veterans of Foreign Wars".		
27	(e)(1) The applicant shall pay a fundraising fee of ten dollars		
28	(\$10.00) for each special license plate issued or renewed under this section.		
29	(2)(A) Additional fees shall not be charged for issuance of the		
30	first special license plate under this section to an eligible applicant.		
31	(B) The Director of the Department of Finance and		
32	Administration may charge an annual renewal fee for an eligible applicant's		
33	first special license plate issued under this section not to exceed one		
34	dollar (\$1.00).		
35	(3) Additional special license plates may be issued to and		
36	renewed by an eligible applicant under this section upon payment of the fee		

1	required by law for registration or renewal of registration of the motor		
2	vehicle.		
3	(4) The fee set forth in subdivision (e)(1) of this section		
4	shall be remitted monthly to The Nick Bacon VFW Special Veterans Scholarship		
5	<u>Fund</u> .

7	27-24-213. Veterans of Foreign Wars motorcycle license plates.		
8	(a) As used in this section:		
9	(1) "Eligible applicant" means a person who establishes by		
10	membership card or Lifetime Member card upon initial application that he or		
11	she is a member of the:		
12	(A) Veterans of Foreign Wars;		
13	(B) Ladies Auxiliary to the Veterans of Foreign Wars;		
14	(C) Men's Auxiliary to the Veterans of Foreign Wars;		
15	(D) Auxiliary to the Veterans of Foreign Wwars;		
16	(E) Junior Girls of the Ladies Auxiliary to the Veterans		
17	of Foreign Wars; or		
18	(F) Sons of the VFW; and		
19	(2) "Special motorcycle license plate" means a special license		
20	plate issued under this section for a motorcycle as defined under § 27-20-		
21	<u>101(1).</u>		
22	(b) The Department of Finance and Administration is authorized to		
23	issue a special motorcycle license plate to an eligible applicant.		
24	(c) The Department of Finance and Administration shall design the		
25	special license plate issued under this section in consultation with the		
26	Department of Arkansas Veterans of Foreign Wars.		
27	(d)(l) The special license plate created and issued under this section		
28	shall be free of charge to an eligible applicant.		
29	(2) To defray the cost of the issuance and renewal of a special		
30	license plate under this section, the department may charge an annual fee for		
31	renewal not to exceed one dollar (\$1.00).		
32	(e) The registration of a special license plate under this section may		
33	continue from year to year if it is renewed each year within the time and		
34	manner required by law.
