11 ENSURE THE ELECTION OF THE MOST QUALIFIED CANDIDATE;
12 TO SAVE PUBLIC MONEY AND RESOURCES BY REDUCING THE
13 NUMBER OF ELECTIONS AND ELECTION ADMINISTRATION
14 COSTS; AND FOR OTHER PURPOSES.



25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
26

27 *SECTION 1. Arkansas Code § 7-1-101(20) through (34), concerning*
28 *certain definitions regarding elections, is amended to read as follows:*

29 ~~*(20) "Party filing period" means the period of time established*~~
30 ~~*by law for the candidate for a political party's nomination to file his or*~~
31 ~~*her party certificate with the Secretary of State or county clerk, as the*~~
32 ~~*case may be;*~~

33 ~~*(21)(A)*~~ *(20)(A)* *"Political party" means any group of voters that*
34 *at the last preceding general election polled for its candidate for Governor*
35 *in the state or nominees for presidential electors at least three percent*
36 *(3%) of the entire vote cast for the office.*



1 (B) A group of electors shall not assume a name or
2 designation that is so similar in the opinion of the Secretary of State to
3 that of an existing political party as to confuse or mislead the voters at an
4 election.

5 (C) When any political party fails to obtain three percent
6 (3%) of the total votes cast at an election for the office of Governor or
7 nominees for presidential electors, it shall cease to be a political party;

8 ~~(22)~~(21) "Polling site" means a location selected by the county
9 board of election commissioners where votes are cast;

10 ~~(23)~~(22) "Precinct" means the geographical boundary lines
11 dividing a county, municipality, township, or school district for voting
12 purposes;

13 ~~(24)~~(23) "Primary election" means any election ~~held by a~~
14 ~~political party in the manner provided by law~~ for the purpose of selecting
15 nominees of the political party for certification as candidates for election
16 at any general or special election in this state;

17 ~~(25)~~(24) "Provisional ballot" means a ballot:

18 (A) Cast by special procedures to record a vote when there
19 is some question concerning a voter's eligibility; and

20 (B) Counted contingent upon the verification of the
21 voter's eligibility;

22 ~~(26)~~(25) "Qualified elector" means a person who holds the
23 qualifications of an elector and who is registered pursuant to Arkansas
24 Constitution, Amendment 51;

25 ~~(27)~~(26) "Sample ballot" means a ballot for distribution to the
26 public or the press marked with the word "SAMPLE" so as to prevent the
27 production of counterfeit ballots;

28 ~~(28)~~(27) "Uniformed services" means the United States Army,
29 United States Navy, United States Air Force, United States Marine Corps, and
30 United States Coast Guard, the United States Public Health Service
31 Commissioned Corps, and the National Oceanic and Atmospheric Administration
32 Commissioned Officer Corps, or as defined in the federal Uniformed and
33 Overseas Citizens Absentee Voting Act if different from the definition stated
34 in this subdivision ~~(28)~~(27);

35 ~~(29)~~(28) "Vacancy in election" means the vacancy in an elective
36 office created by death, resignation, or other good and legal cause arising

1 prior to election to the office at a general or special election but arising
2 subsequent to the certification of the ballot;

3 ~~(30) "Vacancy in nomination" means the circumstances in which:~~

4 ~~(A) The person who received the majority of votes at the~~
5 ~~preferential primary election or general primary election cannot accept the~~
6 ~~nomination due to death or notifies the party that he or she will not accept~~
7 ~~the nomination due to serious illness, moving out of the area from which the~~
8 ~~person was elected as the party's nominee, or filing for another office~~
9 ~~preceding the final date for certification of nominations; or~~

10 ~~(B) There is a tie vote for the same office at a general~~
11 ~~primary election;~~

12 ~~(31)(A)(29)(A)~~ (29)(A) "Vacancy in office" means the vacancy in an
13 elective office created by death, resignation, or other good and legal cause
14 arising subsequent to election to the office at a general or special election
15 or arising subsequent to taking office and before the expiration of the term
16 of office in those circumstances wherein the vacancy must be filled by a
17 special election rather than by appointment.

18 (B) ~~The phrase "vacancy"~~ "Vacancy in office" shall not
19 apply to the election of a person at a general election to fill an unexpired
20 portion of a term of office;

21 ~~(32)(30)~~ (30) "Voter-verified paper audit trail" means a
22 contemporaneous paper record of a ballot printed for the voter to confirm his
23 or her votes before the voter casts his or her ballot that:

24 (A) Allows the voter to verify the voter-verified paper
25 audit trail before the casting of the voter's ballot;

26 (B) Is not retained by the voter;

27 (C) Does not contain individual voter information;

28 (D) Is produced on paper that is sturdy, clean, and
29 resistant to degradation; and

30 (E) Is readable in a manner that makes the voter's ballot
31 choices obvious to the voter without the use of computer or electronic code;

32 ~~(33)(31)~~ (31) "Voting machine" means either:

33 (A) A direct-recording electronic voting machine that:

34 (i) Records votes by means of a ballot display
35 provided with mechanical or electro-optical components that may be actuated
36 by the voter;

- 1 (ii) Processes the data by means of a computer
2 program;
- 3 (iii) Records voting data and ballot images in
4 internal and external memory components; and
- 5 (iv) Produces a tabulation of the voting data stored
6 in a removable memory component and on a printed copy; or
- 7 (B) An electronic device for marking a paper ballot to be
8 electronically scanned; and

9 ~~(34)~~(32) "Voting system" means:

10 (A) The total combination of mechanical,
11 electromechanical, or electronic equipment, including the software, firmware,
12 and documentation required to program, control, and support the equipment
13 that is used to:

- 14 (i) Define ballots;
- 15 (ii) Cast and count votes;
- 16 (iii) Report or display election results; and
- 17 (iv) Maintain and produce any audit trail
18 information; and
- 19 (B) The practices and documentation used to:
- 20 (i) Identify system components and versions of
21 components;
- 22 (ii) Test the system during its development and
23 maintenance;
- 24 (iii) Maintain records of system errors and defects;
- 25 (iv) Determine specific system changes to be made to
26 a system after the initial qualification of the system; and
- 27 (v) Make available any materials to the voter,
28 including without limitation notices, instructions, forms, or paper ballots.

30 SECTION 2. Arkansas Code Title 7, Chapter 3, Subchapter 1, is amended
31 to add an additional section to read as follows:

32 7-3-109. Petition requirements for new political parties.

33 (a)(1) A group desiring to form a new political party shall do so by
34 filing a petition with the Secretary of State.

35 (2) The petition shall contain at the time of filing the
36 signatures of at least ten thousand (10,000) registered voters in the state.

1 (3) The Secretary of State shall not accept for filing any new
2 party petition that is not prima facie sufficient at the time of filing.

3 (4)(A) No signature shall be counted unless the date of the
4 signature appears on the petition.

5 (B) No signature that is dated more than ninety (90) days
6 before the date the petition is submitted shall be counted.

7 (5)(A) The petition shall declare the intent of organizing a
8 political party, the name of which shall be stated in the declaration.

9 (B) No political party or group shall assume a name or
10 designation that is so familiar, in the opinion of the Secretary of State, as
11 to confuse or mislead the voters at an election.

12 (6) If a new political party files a sufficient petition no
13 later than forty-five (45) days before the first day in March preceding the
14 general election, a candidate in the general election may file for candidacy
15 with the new political party affiliation.

16 (b)(1) The Secretary of State shall determine the sufficiency of the
17 signatures submitted within thirty (30) days of filing.

18 (2) If the petition is determined to be insufficient, the
19 Secretary of State immediately shall notify the sponsors in writing, through
20 their designated agent, and shall set forth his or her reasons for so
21 finding.

22 (c)(1) Upon certification of sufficiency of the petition by the
23 Secretary of State, a new political party shall be declared by the Secretary
24 of State.

25 (2) A new political party formed by the petition process shall
26 nominate candidates by convention for the first presidential general election
27 after certification.

28 (3) A candidate nominated by convention shall file a political
29 practices pledge with the Secretary of State or county clerk, as the case may
30 be, no later than noon of the date of the preferential primary election.

31 (4) If the new party maintains party status by obtaining three
32 percent (3%) of the total vote cast for the office of Governor or nominees
33 for presidential electors at the first general election after certification,
34 a candidates in the general election may continue to file indicating the
35 party affiliation.

36 (5) Any challenges to the certification of the sufficiency of

1 the petition by the Secretary of State shall be filed with the Pulaski County
2 Circuit Court.

3
4 SECTION 3. Arkansas Code § 7-5-102 is amended to read as follows:

5 7-5-102. Time of general election and general runoff election.

6 ~~On the Tuesday next after the first Monday in November in~~ In every
7 even-numbered year, there shall be held ~~an election~~ in each precinct and ward
8 in this state for the election of all elective state, county, and township
9 officers whose term of office is fixed at two (2) years by the Arkansas
10 Constitution or the General Assembly; for state senators in their respective
11 districts when the terms for which the state senators have been elected
12 expire before the next general election; for Representatives in the Congress
13 of the United States for each congressional district in this state; for
14 United States Senators when the term of office of any United States Senator
15 expires before the next general election; and for prosecuting attorney in
16 this state;

17 (1) A general election held three (3) weeks before the second
18 Tuesday in June; and

19 (2) If necessary, a general runoff election held on the Tuesday
20 next after the first Monday in November.

21
22 SECTION 4. Arkansas Code § 7-5-106(a)(1), concerning the date of a
23 runoff election for county and municipal office, is amended to read as
24 follows:

25 (a)(1) If there are more than two (2) candidates for election to any
26 county elected office, including the office of justice of the peace, at any
27 general election held in this state and no candidate for the county elected
28 office receives a majority of the votes cast for the county elected office,
29 there shall be a runoff general election held in that county ~~three (3) weeks~~
30 ~~following the date of the general election~~ on the Tuesday next after the
31 first Monday in November after the general election at which the names of the
32 two (2) candidates receiving the highest number of votes, but not a majority,
33 shall be placed on the ballot to be voted upon by the qualified electors of
34 the county.

35
36 SECTION 5. Arkansas Code Title 7, Chapter 5, Subchapter 1, is amended

1 to add an additional section to read as follows:

2 7-5-111. Cost and conduct of elections.

3 (a) The cost of the general election, the nonpartisan judicial general
 4 election, the preferential primary election and general primary election for
 5 the office of United States President, a special primary election, and a
 6 special primary runoff election shall be borne by the State of Arkansas and
 7 shall be paid from an appropriation made to the State Board of Election
 8 Commissioners for that purpose.

9 (b)(1) Within each county, the elections shall be conducted by the
 10 county board of election commissioners.

11 (2) The State Board of Election Commissioners may adopt rules
 12 for the administration of elections consistent with the provisions of this
 13 chapter.

14 (3) The State Board of Election Commissioners may withhold
 15 reimbursement of funds to the counties for state-funded elections for failure
 16 to comply with the rules adopted by the State Board of Election Commissioners
 17 for the administration of elections or applicable state election laws until
 18 all requirements are met to the satisfaction of the State Board of Election
 19 Commissioners.

20
 21 SECTION 6. Arkansas Code § 7-5-205 is amended to read as follows:

22 7-5-205. Write-in candidates' votes – When counted.

23 No votes for write-in candidates shall be counted or tabulated unless:

24 ~~(1) The candidate notifies in writing the county board of~~
 25 ~~election commissioners of each county in which the candidate seeks election~~
 26 ~~and files the notice with either:~~

27 ~~(A) The Secretary of State, if a candidate for United~~
 28 ~~States Senate, United States House of Representatives, or any state or~~
 29 ~~district office; or~~

30 ~~(B) The county clerk if a candidate for a county or~~
 31 ~~township office;~~

32 ~~(2) The candidate files with the county clerk or the Secretary~~
 33 ~~of State, as required, a political practices pledge and an affidavit of~~
 34 ~~eligibility for the office at the same time the candidate files his or her~~
 35 ~~notice of write-in candidacy;~~

36 ~~(3) The notice of write-in candidacy, the political practices~~

1 ~~pledge, and the affidavit of eligibility are filed no later than the last day~~
2 ~~of the party filing period; and~~

3 ~~(4) The the name written on the ballot is the same name listed~~
4 ~~on the write-in candidate's political practices pledge, except that any~~
5 ~~abbreviation, misspelling, or other minor variation in the form of the name~~
6 ~~of the candidate shall be disregarded if the intention of the voter may be~~
7 ~~ascertained.~~

9 SECTION 7. Arkansas Code § 7-5-207(a)(1), concerning names included on
10 ballots, is amended to read as follows:

11 (a)(1) Except as provided in subdivisions (a)(2) and (3) of this
12 section, all election ballots provided by the county board of election
13 commissioners of any county in this state for any election shall contain in
14 the proper place the name of every candidate ~~whose nomination for any office~~
15 ~~to be filled at that election~~ that has been certified to the county board and
16 shall not contain the name of any candidate or person who has not been
17 certified.

18
19 SECTION 8. Arkansas Code § 7-5-704 is amended to read as follows:

20 7-5-704. Votes for legislative, judicial, and executive officers – Tie
21 vote.

22 (a) It shall be the duty of the Secretary of State, in the presence of
23 the Governor, within thirty (30) days after the time allowed in this
24 subchapter to make returns of elections by the county board of election
25 commissioners, or sooner, if all the returns have been received, to cast up
26 and arrange the votes from the several counties for each person who received
27 votes for any legislative, judicial, or executive office, except the offices
28 named in Arkansas Constitution, Article 6, § 3. The persons who have received
29 the greatest number of legal votes for Justice of the Supreme Court and
30 Commissioner of State Lands, within the state; judges of the Court of Appeals
31 and of the circuit courts, and prosecuting attorneys, in their respective
32 districts or circuits; judges of the county and probate courts, circuit
33 clerk, county clerk, sheriff, coroner, surveyor, and assessor, in their
34 respective counties; and all other officers required by law, shall be
35 commissioned by the Governor.

36 (b)(1) If two (2) or more persons at a general election have an equal

1 number of votes for the same office and a higher number than any other
2 person, the names of the two (2) candidates receiving the highest number of
3 votes for any legislative or executive office, except those offices named in
4 Arkansas Constitution, Article 6, § 3, and constables, shall be certified to
5 a ~~special general~~ runoff election which shall be held ~~three (3) weeks from~~
6 ~~the day on which the general election is held~~ on the Tuesday next after the
7 first Monday in November after the general election.

8 (2) The special runoff election shall be conducted in the same
9 manner as is now provided by law, and the election results thereof shall be
10 canvassed and certified in the manner provided by law.

11 (c) Subsection (b) of this section shall not apply to the offices of
12 Justice of the Supreme Court, Judge of the Court of Appeals, circuit judge,
13 or district judge.

14
15 SECTION 9. Arkansas Code Title 7, Chapter 5, is amended to add an
16 additional subchapter to read as follows:

17
18 Subchapter 9 – Filing and General Election Proceedings

19
20 7-5-901. Filing as candidate with a party affiliation.

21 (a)(1) A person who files as a candidate for office may indicate a
22 party affiliation to be noted on the ballot.

23 (2) A person who files as a candidate for office indicating a
24 party affiliation to be noted on the ballot shall not:

25 (A) File indicating more than one (1) party affiliation in
26 that election; or

27 (B) File as an independent or write-in candidate in that
28 election.

29 (b)(1) A person who chooses to indicate a party affiliation shall file
30 as a candidate during a one-week period ending at 12:00 noon on the first day
31 in March and beginning at 12:00 noon one (1) week prior to the first day in
32 March before the general election.

33 (2) The person shall submit the:

34 (i) Political practices pledge;

35 (ii) Party certificate; and

36 (iii) Affidavit of eligibility.

1 (3) The political practices pledge, party certificate, and
2 affidavit of eligibility shall be filed with the county clerk or the
3 Secretary of State during regular office hours during the filing period under
4 this section.

5 (4) The name of a candidate who does not file a political
6 practices pledge, party certificate, and affidavit of eligibility by the
7 filing deadline with the Secretary of State or county clerk shall not appear
8 on the ballot.

9 (5) For a special primary election to fill a vacancy in office,
10 a candidate shall file as required under § 7-11-101 et seq.

11 (c)(1) The county clerk shall not accept for filing the political
12 practices pledge and affidavit of eligibility of a candidate seeking to file
13 for candidacy to any county, township, or partisan municipal office
14 indicating an affiliation with a party unless the candidate first files a
15 party certificate.

16 (2) The Secretary of State shall not accept for filing the
17 political practices pledge or affidavit of eligibility of a candidate seeking
18 to file for candidacy to any state or district office indicating an
19 affiliation with a party unless the candidate first files a party
20 certificate.

21 (d)(1) At least seventy-five (75) days before the general election,
22 the Secretary of State shall certify to the various county committees and to
23 the various county boards of election commissioners a list of the names of
24 all candidates who have filed as required under this section with the
25 Secretary of State.

26 (2) At least seventy-five (75) days before the general election,
27 the county clerk shall certify to the county committees and to the county
28 board of election commissioners a list of the names of all candidates who
29 have filed as required under this section with the county clerk.

30 (e)(1) The county board of election commissioners shall convene, at
31 the time specified in the notice to the members given by the chair of the
32 board, no later than the tenth day after each general election for the
33 purpose of canvassing the returns and certifying the election results.

34 (2) If no time is specified for the meeting of the county board
35 of election commissioners, the meeting shall be at 5:00 p.m.

36 (f)(1) The county board of election commissioners shall certify to

1 the county clerk and the county committee of each political party a list of
2 all candidates for county, township, and municipal offices, and the political
3 parties' county committee members and delegates.

4 (2) The county board of election commissioners shall certify to
5 the Secretary of State and the secretary of the state committee the results
6 of the contests for all United States, state, and district offices.
7 Immediately after ascertaining the results for all United States, state, and
8 district offices, the Secretary of State shall certify to the state committee
9 of each political party a list of all candidates for the offices.

10
11 7-5-902. Filing as an independent – Petitions – Disqualification.

12 (a)(1) A person desiring to have his or her name placed upon the
13 ballot as an independent candidate without political party affiliation for
14 any United States office other than President of the United States or Vice
15 President of the United States or state, county, township, or district office
16 in any general election in this state shall file the following during the
17 one-week period ending at 12:00 noon on the first day in March and beginning
18 at 12:00 noon one (1) week prior to the first day in March the year in which
19 the election is to be held:

20 (A) A political practices pledge;

21 (B) An affidavit of eligibility;

22 (C) A notice of candidacy stating the name and title the
23 candidate proposes to appear on the ballot and identifying the elective
24 office sought, including the position number, if any; and

25 (D) A petition under this section.

26 (2)(A) An independent candidate shall state the same position,
27 including the position number, if any, on his or her petition.

28 (B) When a candidate has identified the position sought on
29 the notice of candidacy, the candidate shall not be allowed to change the
30 position but may withdraw a notice of candidacy and file a new notice of
31 candidacy designating a different position before the deadline for filing.

32 (b)(1)(A) If the person is a candidate for county, township, or
33 district office, the petitions shall be signed by the lesser of:

34 (i) Three percent (3%) of the qualified electors in
35 the county, township, or district in which the person is seeking office; or

36 (ii) Two thousand (2,000) qualified electors.

1 (B) If the person is a candidate for state office or for
2 United States Senator in which a statewide race is required, the petition
3 shall be signed by the lesser of:

4 (i) Three percent (3%) of the qualified electors of
5 the state; or

6 (ii) Ten thousand (10,000) qualified electors.

7 (2)(A) Each elector signing the petition shall be a registered
8 voter.

9 (B) The petition shall:

10 (1) Be directed to the official with whom the person
11 is required by law to file the petition to qualify as a candidate; and

12 (2) Request that the name of the person be placed on
13 the ballot for election to the office mentioned in the petition.

14 (3) Petitions shall be circulated not earlier than ninety (90)
15 calendar days before the deadline for filing petitions to qualify as an
16 independent candidate unless the number of days is reduced by a proclamation,
17 ordinance, resolution, order, or other authorized document for a special
18 election under § 7-11-101 et seq.

19 (4) In determining the number of qualified electors in any
20 county, township, or district or in the state, the total number of votes cast
21 therein for all candidates in the preceding general election for the office
22 of Governor shall be conclusive of the number of qualified electors therein
23 for the purposes of this section.

24 (5) If the number of days in which the petition for independent
25 candidacy may be circulated is reduced by a proclamation, ordinance,
26 resolution, order, or other authorized document for a special election under
27 § 7-11-101 et seq., the number of signatures required on the petition shall
28 be reduced proportionately.

29 (c) A person who files as an independent candidate shall not file as a
30 write-in candidate or a candidate indicating a party affiliation in that
31 election.

32
33 7-5-903. Notice of candidacy as a write-in candidate.

34 (a) During a one-week period ending at 12:00 noon on the first day in
35 March and beginning at 12:00 noon one (1) week before the first day in March,
36 a person who seeks to be a write-in candidate for office shall:

1 (1) File with the county clerk or Secretary of State:

2 (A) A notice of write-in candidacy;

3 (B) A political practices pledge; and

4 (C) The affidavit of eligibility; and

5 (2) Notify the county board of election commissioners of each
6 county in which the candidate seeks election of his or her intent and filing.

7 (b)(1) If the person seeks election as a write-in candidate for the
8 office of United States Senate, the office of United States House of
9 Representatives, or any state or district office, the notice shall be filed
10 with the Secretary of State.

11 (2) If the person seeks election as a write-in candidate for a
12 county or township office, the person shall file notice of write-in candidacy
13 with the county clerk.

14 (c) A candidate shall not run for office as a write-in candidate in a
15 special election to fill a vacancy under Arkansas Constitution, Amendment 29.

16
17 7-5-904. Party certificate and political party filing fees.

18 (a)(1) A political party may impose a filing fee for candidates
19 seeking to indicate on the ballot an affiliation with that party.

20 (2)(A) The filing fee for county, municipal, and township
21 offices shall be fixed by the county committee of the political party, as
22 authorized by the state committee of the political party.

23 (B) The filing fee for all other offices shall be
24 established by the state committee of the political party.

25 (3) A candidate seeking a party certificate shall:

26 (A) File an affidavit of eligibility;

27 (B) File a party pledge if any is required by the party;

28 and

29 (C) Pay the party filing fees if filing fees are required
30 by the party.

31 (b)(1) Candidates for United States Senator, United States
32 Representative, State Representative, State Senator, and all state and
33 district offices shall:

34 (A) File the party pledge and the affidavit of eligibility
35 with the secretary of the state committee of the political party or his or
36 her designated agent; and

1 (B) Pay the party filing fees with the secretary of the
2 state committee of the political party or his or her designated agent; and

3 (2) Candidates for county, municipal, and township offices,
4 candidates for county committee member, and delegates to the county
5 convention shall:

6 (A) File the party pledge and the affidavit of eligibility
7 with the secretary of the county committee of the political party; and

8 (B) Pay the party filing fees with the secretary of the
9 county committee of the political party.

10 (c) A candidate who does not file the party pledge and affidavit of
11 eligibility and pay the party filing fee at the time and in the manner
12 provided in this section shall not receive a party certificate and shall not
13 have his or her name printed on the ballot at any general election.

14 (d) The names of candidates who file with the state committee as
15 provided in this section shall be certified to the various county committees
16 and the various county boards of election commissioners in the manner and at
17 the time provided under § 7-5-901.

18
19 7-5-905. General election held with the preferential primary election
20 – Separate ballots.

21 (a) At each general election that is held with the preferential
22 primary election for the office of United States President, each county board
23 of election commissioners shall furnish separate ballots for each political
24 party containing:

25 (1) The names of persons seeking the office of President to be
26 voted on as a nominee or candidate of that political party;

27 (2) The names of candidates for the county committee of that
28 political party, if opposed;

29 (3) The names of all qualified candidates for the general
30 election;

31 (4) The names of all qualified candidates for the nonpartisan
