1	(b) In order to protect the Arkansas State Board of Sanitarians, to		
2	allow for continuation of necessary procedures, and to provide for a smooth		
3	transition to the Arkansas Department of Health, the Arkansas Department of		
4	Health Director may not realign the functions and records of the Arkansas		
5	State Board of Sanitarians before July 1, 2014.		
6			
7	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the General		
8	Assembly of the State of Arkansas that this act transfers the Arkansas State		
9	Board of Sanitarians to the Arkansas Department of Health; that to		
10	effectively administer this act the transition should occur at the beginning		
11	of the next fiscal year; and that the effectiveness of this act on July 1,		
12	2013, is essential to the operation of the agencies. Therefore, an emergency		
13	is declared to exist and this act being necessary for the preservation of the		
14	public peace, health, and safety shall become effective on July 1, 2013.
