21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 27-15-315(b), concerning parking lot signs
24 for individuals with disabilities, is amended to read as follows:

25 (b)(1) ~~Any of the following designations that are~~ A designation that
26 is displayed on each parking space for ~~persons~~ individuals with disabilities
27 and visible to the driver's eye level shall be enforced as provided under
28 this subchapter and ~~are~~ is regulatory in nature+.

29 ~~(A)(2) A sign that displays the blue and white international~~
30 ~~symbol of access accompanied by one (1) or more of the phrases referenced~~
31 ~~under subdivision (b)(1)(B) of this section;~~ displayed under subdivision
32 (b)(1) of this section shall display the term, "Reserved."

33 ~~(B) A sign that states any of the following+:~~

34 ~~(i) "Disabled Parking";~~

35 ~~(ii) "Van Accessible";~~

36 ~~(iii) "Handicapped Parking";~~

2 ~~(v) “Reserved Parking” with the blue and white~~
3 ~~international symbol of access; or~~
4 ~~(vi) “Permit Required — Towing Enforced”;~~ or
5 ~~(C) A sign that is compliant with R7-8, R7-8a, or R7-8b of~~
6 ~~the Manual on Uniform Traffic Control Devices promulgated by the Federal~~
7 ~~Highway Administration of the United States Department of Transportation.~~
8 ~~(2)(3)~~ Corresponding pavement markings of the blue and white
9 international symbol of access are preferred but not required for enforcement
10 of this subchapter.
