28	SECTION 1. Ark	kansas Code Title 19, Chapter 6, Subcha	pter 8, is amended
29	to add an additional	section to read as follows:	
30	<u>19-6-819. Fall</u>	len Law Enforcement Officers' Beneficia	ry Fund.
31	(a) There is o	created on the books of the Treasurer o	f State, the
32	Auditor of State, and	d the Chief Fiscal Officer of the State	a special revenue
33	fund to be known as t	the "Fallen Law Enforcement Officers' B	eneficiary Fund".
34	(b) The fund s	shall consist of such revenues as may b	e authorized by
35	law.		
36	(c) The fund s	shall be used by the Arkansas Commissio	n on Law

2	beneficiaries of fallen law enforcement officers as determined to be
3	appropriate by the commission.
4	
5	SECTION 2. Arkansas Code § 27-24-1302 is amended to add an additional
6	subsection to read as follows:
7	(6)(A) "Certified law enforcement officer" means any appointed or
8	elected law enforcement officer or county sheriff employed by a law
9	enforcement agency who:
10	(i) Is responsible for the prevention and detection of
11	crime and the enforcement of the criminal, traffic, or highway laws of this
12	state; and
13	(ii) Has met the selection and training requirements for
14	certification set by the Arkansas Commission on Law Enforcement Standards and
15	Training.
16	(B) "Law enforcement agency" means any public police department,
17	county sheriff's office, or other public agency, force, or organization whose
18	primary responsibility as established by law, statute, or ordinance is the
19	enforcement of the criminal, traffic, or highway laws of this state.
20	
21	SECTION 3. Arkansas Code Title 27, Chapter 24, Subchapter 13, is
22	amended to add an additional section to read as follows:
23	27-24-1314. Certified law enforcement officers.
24	(a) The Department of Finance and Administration shall create and
25	issue a special license plate for certified law enforcement officers under
26	this section.
27	(b) The department shall seek the advice of the Arkansas Commission on
28	Law Enforcement Standards and Training regarding the design of the special
29	license plate under this section.
30	(c)(1) A certified law enforcement officer may apply for and renew
31	annually a special license plate issued under this section.
32	(2) The fee for the initial application for a special license
33	plate under this section is:
34	(A) The fee required by law for the registration and
35	licensing of the motor vehicle;
36	(B) A handling and administrative fee in the amount of ten

1	dollars (\$10.00); and
2	(C) An additional fee of twenty-five dollars (\$25.00) to
3	be remitted monthly in the following manner:
4	(i) Seventy-five percent (75%) shall be remitted to

6	(ii) Twenty-five percent (25%) to the Fallen Law
7	Enforcement Officers' Beneficiary Fund.
8	(3) The fee for the renewal of a special license plate under
9	this section is the fee required by law for the registration and licensing of
10	the motor vehicle and an additional fee of twenty-five dollars (\$25.00) to be
11	remitted monthly in the following manner:
12	(i) Seventy-five percent (75%) shall be remitted to
13	the Arkansas Law Enforcement Training Academy Cash Fund; and
14	(ii) Twenty-five percent (25%) to the Fallen Law
15	Enforcement Officers' Beneficiary Fund.
16	(4) The replacement fee for a special license plate issued under
17	this section is ten dollars (\$10.00).
18	(d)(1) Upon the initial application for a special license plate issued
19	under this section, the law enforcement officer shall provide adequate proof
20	to the department that he or she is:
21	(A) A certified law enforcement officer as defined in §
22	<u>27-24-1302</u> ; or
23	(B) Retired from active service as a certified law
24	enforcement officer as defined in § 27-24-1302.
25	(2) This subsection shall not require a person who has been
26	issued a license plate under this section to present adequate proof of his or
27	her status as a certified law enforcement officer or retired law enforcement
28	officer to the department for the renewal of his or her license and
29	registration.
30	(e)(1) The fee remitted under subdivision (c)(2)(B) of this section
31	shall be deposited into the State Central Services Fund as direct revenue to
32	the Revenue Division of the Department of Finance and Administration.
33	(2) The fee shall be credited as supplemental and in addition to
34	all other funds as may be deposited for the benefit of the division.
35	(3) The fee shall not be considered or credited to the division
36	as direct revenue.

1	(1)(1) The department shall offer a banner of tape to be attached to
2	the special license plates issued under this section that states "Retired".
3	(2) The "Retired" banner or tape shall be made available to a
4	license plate holder who establishes that he or she is a law enforcement
5	officer retired from active service as provided under this section.
6	(3) This subsection does not to require a person who has been
7	issued a "Retired" banner or tape under this section to present adequate
8	proof of his or her status as a retired law enforcement officer for the
9	renewal of his or her license and registration.
10	
11	SECTION 4. Arkansas Code Title 27, Chapter 24, Subchapter 14, is
12	amended to add additional sections to read as follows:
13	27-24-1411. "Support Law Enforcement" special license plate.
14	(a) The Director of the Department of Finance and Administration shall
15	create and issue a special license plate for support of law enforcement in
16	the manner and subject to the conditions provided for under this subchapter.
17	(b) The Support Law Enforcement motor vehicle special license plate
18	shall be:
19	(1)(A) Designed by the Arkansas Commission on Law Enforcement
20	Standards and Training.
21	(B) The design shall be submitted for design approval by
22	the director under rules promulgated by the director; and
23	(2) Numbered consecutively.
24	(c) The procedures concerning costs for issuance under § 27-24-
25	1404(c)(1)(A) shall apply.
26	(d) The Department of Finance and Administration shall issue a special
27	license plate under this section upon payment of:
28	(1) The fee required by law for registration of the motor
29	vehicle;
30	(2)(A) Twenty-five dollars (\$25.00) to cover the design-use
31	contribution.
32	(B) The design-use contribution shall be remitted monthly
33	in the following manner:
34	(i) Seventy five percent (75%) shall be remitted to
35	the Arkansas Law Enforcement Training Academy Cash Fund; and

16	27-24-1405(b)(2) on a monthly basis as set forth in subsection (d)(2)(B) of
17	this section.

19	27-24-1412. Arkansas Sheriffs' Association.
20	(a) The Director of the Department of Finance and Administration shall
21	issue a special license plate for the Arkansas Sheriffs' Association in the
22	manner and subject to the conditions provided for under this subchapter.
23	(b) The Arkansas Sheriffs' Association motor vehicle special license
24	plate shall be:
25	(1)(A) Designed by the Arkansas Sheriffs' Association.
26	(B) The design shall be submitted for design approval by
27	the director under rules promulgated by the director; and
28	(2) Numbered consecutively.
29	(c) The procedures concerning costs for issuance under § 27-24-
30	1404(c)(1)(A) shall apply.
31	(d) The Department of Finance and Administration shall issue a special
32	license plate under this section upon payment of:
33	(1) The fee required by law for registration of the motor
34	vehicle;
35	(2)(A) Twenty-five dollars (\$25.00) to cover the design-use
36	contribution.

1	(B) The design-use contribution shall be remitted monthly

18	(e)(1) A special license plate issued under this section may be
19	renewed annually or replaced under the procedures set out in § 27-24-1405.
