5	(2) However, a towing entity that receives three disciplinary
6	actions within one (1) year after the sale or transfer of the inclusion on a
7	towing rotation list shall be removed from the towing rotation list and
8	disqualified from inclusion on a towing rotation list for a period of two (2)
9	<u>years.</u>
10	(d) A person engaged in nonconsent towing shall be available for
11	after-hours release of a vehicle or related items.
