1	(B) The functions of an electronic poll book may include				
2	without limitation:				
3	(i) Voter lookup;				
4	(ii) Voter verification;				
5	(iii) Voter identification;				
6	(iv) Precinct assignment;				
7	(v) Ballot assignment;				
8	(vi) Recording when a voter presents himself or				
9	herself to an election official and requests a ballot; and				
10	(vii) Redirecting voters to the correct polling				
11	site.				
12	(b) Precinct voter registration lists shall contain the name, address				
13	including zip code, and date of birth of each registered voter within the				
14	precinct, including those who have been designated inactive, the precinct				
15	number and county wherein the precinct is located, the name and date of the				
16	election, and a space for the voter's signature.				
17	(c) The following shall be printed at the top of each page of the				
18	precinct voter registration list:				
19	"IF YOU SIGN THIS FORM AND YOU ARE NOT A LAWFULLY REGISTERED VOTER, YOU ARE				
20	MAKING A FALSE STATEMENT AND MAY BE COMMITTING PERJURY. PERJURY IS PUNISHABLE				
21	BY UP TO A \$10,000 FINE AND UP TO 10 YEARS IMPRISONMENT."
