6	(a)(l) In a dispute over the amount of wages due to an employee, an
7	employer shall pay, without condition, all wages or parts of wages that the
8	employer concedes to be due to the employee.
9	(2) After a payment under subdivision (a)(1) of this section,
10	the employee retains all remedies to which he or she might otherwise be
11	entitled regarding any balance claimed.
12	(b)(1) The acceptance by an employee of a payment under this section
13	does not constitute a release of the employee's claim to the balance of his
14	<u>or her claim.</u>
15	(2) A release required by an employer as a condition of payment
16	<u>is void.</u>
