1	in March of the year in which the election is to be held.
2	(B) The filing fee for a nonpartisan candidate for sheriff
3	is equal to three percent (3%) of the annual salary of the office which the
4	candidate is filing for, and shall be paid to the county clerk to be
5	deposited into a cash fund in the State Treasury, and disbursed by the
6	Treasurer of State to the Arkansas Sheriffs' Association for grants to
7	Arkansas Sheriffs' Youth Ranches.
8	(2)(A)(i) A person desiring to have his or her name placed on
9	the ballot as a nonpartisan candidate for sheriff without paying a filing fee
10	may do so by filing a petition with the county clerk signed by at least three
11	percent (3%) of the qualified electors residing within the county for which
12	the candidate seeks office.
13	(ii) In determining the number of qualified electors
14	in the county under subdivision (c)(2)(A)(i) of this section, the total
15	number of all votes cast in the county for Governor in the immediately
16	preceding general gubernatorial election shall be conclusive of the number of
17	qualified electors residing within the county.
18	(B) The petition, the political practices pledge, and the
19	affidavit of eligibility shall be filed during a one-week period ending at
20	12:00 noon on the first day in March of the year in which the election is to
21	<u>be held.</u>
22	(C) The county clerk shall verify the sufficiency of the
23	petition within thirty (30) days of filing.
24	(D) The sufficiency of a petition filed under this section
25	may be challenged in the same manner as election contests under § 7-5-801 et
26	<u>seq.</u>
27	(3)(A) Votes for a write-in nonpartisan candidate for sheriff in
28	an election shall not be counted or tabulated unless the candidate or his or
29	her agent files notice in writing of his or her intention to be a write-in
30	candidate for sheriff to the county board of election commissioners and the
31	county clerk.
32	(B) The written notice shall be filed not later than
33	ninety (90) days before the election.
34	(C) A write-in candidates shall file a political practices

(d)(1) A nonpartisan candidate for sheriff may not use more than three

16	(2) If the nonpartisan office of sheriff is unopposed, the	
17	single candidate for sheriff shall be printed on the general election ballot	
18	and the votes for sheriff shall be tabulated as in all contested races.
