2	certificate of origin or the original document of title to a manufactured		
3	home or mobile home upon receipt of:		
4	(1) The original manufacturer's certificate of origin or the		
5	original document of title showing an assignment of the manufactured home or		
6	mobile home to the party that will affix the manufactured home or mobile home		
7	to the real estate;		
8	(2) An application for cancellation of the manufacturer's		
9	certificate of origin or the original document of title; and		
10	(3)(A) A copy of an affidavit of affixation to be recorded under		
11	§ 14-15-402 in the county in which the manufactured home or mobile home is to		
12	be affixed.		
13	(B) The affidavit of affixation shall include:		
14	(i) The name of the manufacturer, the make, the		
15	model name, the model year, the dimensions, and the manufacturer's serial		
16	number of the manufactured home or mobile home;		
17	(ii) A statement that the party executing the		
18	affidavit of affixation is:		
19	(a) The owner of the real estate described in

8	(c) The department shall also cancel an existing title or		
9	manufacturer's certificate of origin to any home to be affixed to real estate		
10	if the owner affixing the home:		
11	(1) Submits the documents and information identified in		
12	subsection (b) of this section;		
13	(2) Submits:		
14	(A) A court order directing the department to issue a		
15	title for cancellation;		
16	(B) An application for cancellation of title or		
17	manufacturer's certificate of origin; and		
18	(C) A copy of an affidavit of affixation to be recorded		
19	under § 14-15-402 in the county in which the home is to be affixed; or		
20	(3) Follows the bonded title procedure of this state under §		
21	27-14-409(c) and submits an application for cancellation of title or		
22	manufacturer's certificate of origin and a copy of an affidavit of affixation		
23	to be recorded under § 14-15-402 in the county in which the home is to be		
24	affixed.		
25	$\frac{(b)(1)}{(d)}$ The Director of the Department of Finance and		
26	Administration may require the filing of pertinent information for the		
27	cancellation of manufactured home titles or mobile home titles.		
28	(2) The director shall have the authority to may promulgate rules and		
29	regulations to establish a procedure for the cancellation of manufactured		
30	home titles or mobile home titles to administer this section.

32	SECTION 3. Arkansas Code Title 27, Chapter 14, Subchapter 16, is		
33	amended to add a new section to read as follows:		
34	27-14-1604. Issuance of new title in the event of severance.		
35	(a) As used in this section:		
36	(1) "Lender applicant" means an individual or entity that

intends to sever a manufactured home or mobile home from the real estate to 1 2 which it is affixed and is a lender in possession of the manufactured home or 3 mobile home that holds a lien, security interest, or encumbrance against the 4 manufactured home or mobile home for which a title has been cancelled under § 5 27-14-1603; and 6 (2) "Owner applicant" means an individual or entity that intends 7 to sever a manufactured home or mobile home from the real estate to which it 8 is affixed and is the owner or purchaser of the manufactured home or mobile 9 home. 10 (b) The Department of Finance and Administration shall issue a new certificate of title for a manufactured home or mobile home to be severed 11 12 from the real estate to which it is affixed upon receipt of the following 13 from a lender applicant or an owner applicant: 14 (1) A completed application for title accompanied by payment of 15 a registration fee of twenty-six dollars (\$26.00) and a title fee of ten 16 dollars (\$10.00); 17 (2) Proof of payment of the current year's property taxes, if 18 any; 19 (3) The following information: 20 (A) If there are no liens, security interests, or 21 encumbrances against the manufactured home or mobile home, a notarized 22 statement from the owner applicant that there are no liens, security 23 interests, or encumbrances upon the home; 24 (B) If there are no liens, security interests, or encumbrances against the manufactured home or mobile home other than that of 25 26 a lender in possession of the home that holds a lien, security interest, or 27 encumbrance against the manufactured home or mobile home, a notarized 28 statement from the lender applicant that there are no liens, security 29 interests, or encumbrances upon the manufactured home or mobile home other 30 than that of the lender applicant; or 31 (C) If the manufactured home or mobile home is encumbered 32 by a lien, security interest, or encumbrance other than that of a lender 33 applicant, a statement from an attorney licensed to practice law in Arkansas 34 or an authorized agent of a title insurance company licensed in Arkansas that

certifies the order of priority for the new certificate of title of each

lien, security interest, or encumbrance upon the manufactured home or mobile

2	(4)(A) A copy of an affidavit of severance to be recorded under		
3	§ 14-15-402 in the county in which the manufactured home or mobile home was		
4	affixed.		
5	(B) The affidavit of severance shall include the name,		
6	residence, and mailing address of the applicant and a description of the		
7	manufactured home or mobile home, including without limitation the name of		
8	the manufacturer, make, model name, model year, dimensions, and the		
9	manufacturer's serial number of the manufactured home or mobile home; and		
10	(5) Relevant supporting documents and recording information		
11	concerning a lien, security interest, or encumbrance upon the manufactured		
12	home or mobile home if requested by the department.		
13	(c) The department shall also issue a new certificate of title for a		
14	$\underline{\text{manufactured home or mobile home to be severed from the real estate to } \text{which}$		
15	it is affixed if the applicant:		
16	(1) Presents a court order directing the department to issue a		
17	new title and submits an application for issuance of a new certificate of		
18	title or manufacturer's certificate of origin and a copy of an affidavit of		
19	severance to be recorded under § 14-15-402 in the county in which the		
20	manufactured home or mobile home is to be affixed; or		
21	(2) Follows the bonded title procedure under § 27-14-409(c), and		
22	submits an application for cancellation of title or manufacturer's		
23	certificate of origin and a copy of an affidavit of affixation to be recorded		
24	under § 14-15-402 in the county in which the manufactured home or mobile home		
25	<u>is to be affixed.</u>		
26	(d) The Director of the Department of Finance and Administration may		
27	promulgate rules to implement and administer this section.
