1 (a) There is hereby created the Southern Growth Policies Board, 2 hereinafter called "the board." 3 (b) The board shall consist of five (5) members from each party state, 4 as follows: 5 1. The Governor: 6 2. Two (2) members of the state legislature, one (1) member 7 appointed by the presiding officer of each house of the legislature Speaker 8 of the House of Representatives to serve at his pleasure or in such other 9 manner as the legislature may provide; 10 3. One (1) member appointed by the President Pro Tempore of the 11 Senate to serve at his pleasure; and 12 3.4. Two (2) residents of the state who shall be appointed by 13 the Governor to serve at his pleasure. 14 In making appointments pursuant to paragraph (b) 3, a Governor (c) 15 shall, to the greatest extent practicable, select persons who, along with the 16 other members serving pursuant to paragraph (b), will make the state's 17 representation on the board broadly representative of the several socio-18 economic elements within his state. 19 (d) 20 1. A Governor may be represented by an alternate with power to 21 act in his place and stead, if notice of the designation of such alternate is 22 given to the board in such manner as its bylaws may provide. 23 2. A legislative member of the board may be represented by an 24 alternate with power to act in his place and stead, unless the laws of his 25 state prohibit such representation and if notice of the designation of such 26 alternate is given to the board in such manner as its bylaws may provide. An 27 alternate for a legislative member of the board shall be selected by the 28 member from among the members of the legislative house in which he serves. 29 3-2. A member of the board serving pursuant to paragraph (b) 3 30 of this Article may be represented by another resident of his state who may 31 participate in his place and stead, except that he shall not vote; provided 32 that notice of the identity and designation of the representative selected by 33 the member is given to the board in such manner as its bylaws may provide. 34 SECTION 3. 1 The three (3) Arkansas members on the Southern States Energy Board (a) 2 shall be selected as follows: 3 (1) The Governor shall be ex officio a member of the board, or 4 the Governor, at his or her discretion, may name some other resident elector 5 of this state to serve on the board in his or her place, to serve at the 6 pleasure of the Governor; 7 (2)(A) At each regular session of the General Assembly, the The 8 Speaker of the House of Representatives shall name appoint one (1) member 9 thereof resident elector of this state to serve on the board. 10 This member shall serve until the convening of the (B) 11 next regular session of the General Assembly or until his or her successor is 12 appointed; and 13 (3)(A) At each regular session of the General Assembly, the The 14 President Pro Tempore of the Senate shall name appoint one (1) member of the 15 Senate resident elector of this state to serve on the board for a term of two 16 (2) years. 17 This member shall serve until the convening of the (B) 18 next regular session of the General Assembly or until his or her successor is 19 appointed. 20 Vacancies on the board shall be filled in the manner provided (b) 21 herein for the initial appointment. 22 (c)(1) Legislative members Members of the board appointed by the 23 Speaker of the House of Representatives and the President Pro Tempore of the 24 Senate shall be reimbursed for their reasonable and necessary expenses for 25 meals, lodging, travel, and related expenses for attending board meetings, 26 with these expenses to be paid from funds available to their respective 27 houses the house of the member of the General Assembly appointing the 28 respective member of the board. 29 (2)(A) The Governor or the member of the board appointed to 30 serve in the place of the Governor shall be reimbursed for travel expenses in 31 attending board meetings. 32 These expenses shall be payable from funds available (B) 33 for the support of the Governor's office or from funds available to a state 34 agency if the member appointed to serve on the board in the place of the 35 Governor is an official or employee of a state agency. 36
