21	SECTION 1. Arkansas Code Title 23, Chapter 79, is amended to add an	
22	additional subchapter to read as follows:	
23	Subchapter 15 — Coverage for Craniofacial Anomaly Corrective Surgery	
24	23-79-1501. Definitions.	
25	As used in this subchapter:	
26 2 7	(1) "Corrective surgery" means the use of surgery to alter the	
27	form and function of the cranial facial tissues due to a congenital or	
28	acquired musculoskeletal disorder;	
29 30	(2) "Craniofacial anomaly" means a congenital or acquired	
31	musculoskeletal disorder that primarily affects the cranial facial tissue;	
32	and (3)(A) "Health benefit plan" means an individual, blanket, or

1	(B) "Health benefit plan" includes:
2	(i) Indemnity and managed care plans; and
3	(ii) Governmental plans as defined in 29 U.S.C. §
4	1002(32), as it existed on January 1, 2013.
5	(C) "Health benefit plan" does not include:
6	(i) Disability income plans;
7	(ii) Credit insurance plans;
8	(iii) Insurance coverage issued as a supplement to
9	liability insurance;
10	(vi) Medical payments under automobile or
11	homeowners' insurance plans;
12	(v) Health benefit plans provided under Arkansas
13	Constitution, Article 5, § 32, the Workers' Compensation Law, § 11-9-101 et

16	(vi) Plans that provide only indemnity for hospital

19	23-79-1502. Craniofacial anomaly — Coverage for corrective surgery
20	required.
21	(a)(l) A health benefit plan that is offered, issued, or renewed in
22	this state shall offer coverage for corrective surgery and related medical
23	care for persons of any age who have been diagnosed as having a craniofacial
24	anomaly if the surgery and treatment are medically necessary as determined by
25	a nationally accredited cleft-craniofacial team.
26	(2) A nationally accredited cleft-craniofacial team shall:
27	(A) Evaluate persons with craniofacial anomalies; and
28	(B) Coordinate a treatment plan for each person.
29	(b) Medical care covered under this section includes corrective
30	surgery, dental care, vision care, and the use of one (1) or more hearing
31	aids.
