2	(b)(1) A permit issued pursuant to this act for on-premises
3	consumption of alcoholic beverages, wine, or beer shall be revoked for cause
4	for one (1) year upon the third violation in a calendar year of the rules of
5	the Alcoholic Beverage Control Division or state law.
6	(2) The finding of a violation is to be made after a hearing
7	under §§ 3-2-212-3-2-217, and the rules of the division.
8	(c) A holder of a permit authorizing the sale of alcoholic beverages,
9	wine, or beer for consumption on-premises or a servant, agent, or employee of
10	the permit holder shall not do the following upon the permitted premises,
11	including without limitation:
12	(1) Sell or serve alcoholic beverages, beer, or wine to a person
13	less than twenty-one (21) years of age;
14	(2) Sell or serve alcoholic beverages, beer, or wine to a person
15	while the person is in an intoxicated condition;
16	(3) Sell or serve alcoholic beverages, beer, or wine upon the
17	permitted premises or permit alcoholic beverages, beer, or wine to be
18	consumed thereon, on a day or at a time when the sale or consumption is
19	prohibited by law;
20	(4) Permit a prostitute to frequent the licensed premises;
21	(5)(A) Permit gambling or games of chance upon the permitted
22	premises.
23	(B) Permitting gambling or games of chance under
24	subdivision (5)(A) of this section does not include:
25	(i) Charitable bingo and raffles under the
26	Charitable Bingo and Raffles Enabling Act, § 23-114-101 et seq.; or
27	(ii) A lottery under the Arkansas Scholarship
28	Lottery Act, § 23-115-101 et seq.;
29	(6) Permit on the permitted premises any disorderly conduct,
30	breach of the peace, or lewd, immoral, or improper entertainment, conduct, or
31	<u>practices;</u>
32	(7) Permit the handling of alcoholic beverages, wine, or beer by
33	a minor under § 3-3-204;
34	(8) Place a sign on the exterior of the permitted premises
35	indicating that alcoholic beverages, beer, or wine are sold for consumption

7	(12) Dilute or otherwise tamper with the contents of a container

9	(13) Remove or obliterate a label, mark, or stamp affixed to a
10	container of alcoholic beverages, beer, or wine offered for sale; and
11	(14) Deliver or sell the contents of a container, the label,
12	mark, or stamp upon which has been removed or obliterated.
