5	for one (1) year upon the second violation in a calendar year of the rules of		
6	the Alcoholic Beverage Control Division or state law regarding a knowing or		
7	unknowing sale or service of alcoholic beverages, wine, or beer to a person		
8	less than twenty-one (21) years of age.		
9	(2) The finding of a violation is to be made after a hearing		
10	under §§ 3-2-212-3-2-217, and the rules of the division.
