For An Act To Be Entitled

8 AN ACT TO CREATE THE ELECTION EFFICIENCY ACT OF 2013;
9 TO ENCOURAGE VOTER TURNOUT AT ELECTIONS; TO AMEND THE
10 LAW CONCERNING THE DATES ON WHICH CERTAIN ELECTIONS
11 CAN BE HELD; AND FOR OTHER PURPOSES.

Subtitle

15 TO CREATE THE ELECTION EFFICIENCY ACT OF
16 2013.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 2-16-504(b)(1), concerning elections to
22 establish Johnson Grass Control districts, is amended to read as follows:

23 (b)(1) ~~Immediately upon the submission of~~ If the petition ~~to the~~
24 ~~county court or courts~~ is submitted under subdivision (a)(1) of this section,
25 the court or courts shall issue a proclamation calling the election ~~in~~
26 ~~accordance with~~ under § 7-11-201 et seq. and notify the county board or
27 boards of election commissioners in writing. The election shall be held on a
28 date ~~in accordance with~~ under § 7-11-201 et seq. ~~but in no event more than~~
29 ~~ninety (90) days following publication of the proclamation.~~

31 SECTION 2. Arkansas Code § 3-8-302(a), concerning election date by
32 petition regarding wholesale alcohol, is amended to read as follows:

33 (a) ~~Upon application by~~ If a written petition, signed by a number of
34 legal voters in ~~any~~ a county, city, town, district, or precinct to be
35 affected equal to thirty-five percent (35%) of the qualified voters is
36 submitted, it shall be the duty of the judge of the county court in the



1 county shall at the next regular term ~~thereof~~, after receiving the petitions,
 2 ~~to make an~~ enter a written order ~~on his or her order book~~ directing an
 3 election to be held in the county, city, town, district, or precinct to be
 4 affected ~~thereby~~, on ~~some day named in the petition no earlier than sixty~~
 5 ~~(60) days after the application is lodged with the judge of the court~~ a date
 6 authorized under § 7-11-304. However, in counties having two (2) judicial
 7 districts, the legal voters in either district may petition for an election
 8 and the election can only affect the judicial district where the election may
 9 be held.

 11 SECTION 3. Arkansas Code § 6-14-102 is amended to read as follows:

12 6-14-102. Annual school election date – Special school election.

13 (a)(1) The annual school election shall be held in each school
 14 district of the state on the third Tuesday in September.

15 (2) The annual school election shall only concern issues
 16 authorized to be on the ballot by the Arkansas Constitution or by statute,
 17 and no other issues shall appear on the ballot.

18 (b) The board of directors of ~~any a~~ school district ~~shall have the~~
 19 ~~authority to~~ may hold a school election concerning the tax rate or debt
 20 issues on a date under § 7-11-304 ~~other than that fixed by law~~ provided that:

21 (1) All constitutional and statutory requirements for the annual
 22 school election are met, notwithstanding ~~subdivision~~ subsection (a)(1) of
 23 this section;

24 (2) The election is held before the date of the annual school
 25 election; and

26 (3) The Commissioner of Education approves the date of the
 27 election.

28 (c)(1) In ~~any an annual school~~ election ~~year~~ or special school
 29 election, if no more than one (1) candidate for ~~any each~~ school district
 30 director position presents a petition or notice as required by § 6-14-111 and
 31 if there ~~are~~ is no other ~~ballot issues to be submitted to school district~~
 32 ~~electors for consideration~~ issue, measure, question, or candidate on the
 33 ballot, with the exception of the local tax rate if that rate is not being
 34 changed or restructured, the board of directors of ~~any a~~ school district, by
 35 resolution, may request the county board of election commissioners to reduce
 36 the number of polling places or to open no polling places on election day so

1 that the election can be conducted by absentee ballot and early voting only.

2 (2)(A) If requested by ~~proper~~ resolution adopted by the board of
 3 directors of ~~any a~~ school district, the county board of election
 4 commissioners ~~may~~ shall provide that no polling places be open on election
 5 day so that the election can be conducted by absentee ballot and early voting
 6 only.

7 (B) In a county that uses voting machines or electronic
 8 vote tabulating devices, the county board of election commissioners may
 9 ~~choose to~~ use paper ballots counted by hand and ~~may provide that~~ use no
 10 voting machines ~~shall be used~~ in the election, notwithstanding any other
 11 provision in the Arkansas Code.

12
 13 SECTION 4. Arkansas Code § 6-53-602(b)(2), concerning publication of
 14 proclamation by a community college, is amended to read as follows:

15 (2)(A) The local board or acting local board shall issue a
 16 proclamation and set a date for the election under § 7-11-201 et seq., ~~but~~
 17 ~~the date set for the election shall not be later than~~

18 (B) The local board or acting local board shall publish
 19 the proclamation at least ninety (90) days after the publication of the
 20 proclamation before the election date.

21
 22 SECTION 5. Arkansas Code § 6-53-603(a)(2), concerning the date of
 23 election for a tax levy called by a local board of a community college, is
 24 amended to read as follows:

25 (2) ~~It~~ The tax may be reduced or repealed, with the exception of
 26 the amount of tax required to service ~~any an~~ outstanding ~~bonds~~ bond, or the
 27 tax may be increased upon approval ~~thereof~~ by a majority of the qualified
 28 electors of the district voting on the issue at ~~an~~ the next election called
 29 by the local board or acting local board to be held ~~at least thirty (30)~~
 30 ~~calendar days after the local board or acting local board notifies the county~~
 31 ~~boards of election commissioners~~ under § 7-11-304.

32
 33 SECTION 6. Arkansas Code § 6-53-604(b), concerning dissolution of a
 34 technical college district, is amended to read as follows:

35 (b)(1) ~~The petitions~~ A petition shall be filed with the Secretary of
 36 State, ~~who, within.~~

1 (2) The Secretary of State shall within ten (10) days of the
 2 receipt and verification ~~by the Secretary of State~~ of the sufficiency of the
 3 ~~petitions, shall~~ a petition notify the county ~~boards~~ board of election
 4 commissioners and the county clerk in each county in the district that an
 5 election ~~shall~~ is to be held ~~at a time not less than thirty (30) days nor~~

 36 election shall be labeled with a heading stating "SPECIAL ELECTION ON

1 _____ ” with
 2 a brief description of the measure or question to be decided in the election.

3 (3) Separate ballots containing the issue or issues to be voted
 4 on at the special election and candidates for nonpartisan judicial office
 5 shall be prepared and made available to voters requesting a separate ballot.

6 (4) A voter shall not be required to vote in a political party’s
 7 preferential primary in order to be able to vote in the special election.

8 ~~(b)(1) A special election shall be held not less than seventy (70)~~
 9 ~~days following the date that the proclamation, ordinance, resolution, order,~~
 10 ~~or other authorized document is filed with the county clerk when the special~~
 11 ~~election is to be held on the date of the preferential primary election or~~
 12 ~~general election.~~

13 ~~(2) If the special election is not held at the same time as a~~
 14 ~~preferential primary election or general election, the special election shall~~
 15 ~~be held not less than sixty (60) days following the date that the~~
 16 ~~proclamation, ordinance, resolution, order, or other authorized document is~~
 17 ~~filed with the county clerk.~~

 19 SECTION 9. Arkansas Code Title 7, Chapter 11, Subchapter 3, is amended
 20 to add an additional section to read as follows:

21 7-11-304. Dates of special elections.

22 (a) The proclamation, ordinance, resolution, order, or other
 23 authorized document calling a special election shall:

24 (1) Set the date of the special election; and

25 (2) Be filed at least one hundred twenty (120) days before the
 26 date the special election is to be held.

27 (b) If a special election is called in a year in which a preferential
 28 primary election or general election is held, the special election shall be
 29 held with the preferential primary election or general election.

30 (c) If a special election is called in a year in which a preferential
 31 primary election or general election is not held, the special election shall
 32 be held on the Tuesday next after the first Monday in May or the Tuesday next
 33 after the first Monday in November.

34 (d) This section does not apply to a special election to fill a
 35 vacancy in office, a special runoff election, or a special election otherwise
 36 provided for by law.

2 SECTION 10. Arkansas Code § 11-10-1006(a), concerning elections for
3 Arkansas Unemployment Trust Fund Bonds, is amended to read as follows:

4 (a)(1) Arkansas Unemployment Trust Fund Bonds shall not be issued
5 under this subchapter unless the issuance of bonds has been approved by a
6 majority of the qualified electors of the state voting on the question at a
7 statewide election called by proclamation of the Governor as provided under §
8 11-10-1005.

9 (2)(A) An election under this section may be in conjunction with
10 a general election, or it may be a special election.

11 (B) A special election held under this section shall ~~occur~~
12 ~~on the second Tuesday of any month, except as otherwise provided for in this~~
13 ~~subsection.~~

14 ~~(C) A special election that is held in months in which a~~

28 (iii) A voter shall not be required to vote in a
29 political party's ~~presidential preferential primary election, preferential~~
30 ~~primary election, or general~~ primary election in order to be able to vote in
31 the special election.

32 ~~(E) Special elections scheduled to occur in a month in~~
33 ~~which the second Tuesday is a legal holiday shall be held on the third~~
34 ~~Tuesday of the month.~~

35
36 SECTION 11. Arkansas Code § 14-14-917(a)(2), concerning special

1 elections for referendum petition measures, is amended to read as follows:

2 (2) Referendum. ~~Referendum~~ A referendum petition ~~measures~~
 3 measure may be submitted to the electors during a regular general election
 4 and shall be submitted if the ~~adequacy of the~~ petition is determined to be
 5 adequate within the time limitation prescribed in this section. A referendum
 6 measure may also be referred to the electors at a special election called for
 7 the expressed purpose proposed by the petition. ~~However, no~~ A referendum
 8 petition certified within the time limitations established for initiative
 9 measures shall not be referred to a special election, but shall be voted upon
 10 at the next regular election. ~~No~~ A referendum election shall be held ~~less~~
 11 ~~than sixty (60) days after the certification of adequacy of the petition by~~

 14 SECTION 12. Arkansas Code § 14-20-108(a)(1)(B)(i)(b), concerning

 16 on residences, is amended to read as follows:

 18 at a special election by order of the quorum court in accordance with § 7-11-
 19 201 et seq.

20 ~~(2) The special election shall be held~~

 23 SECTION 13. Arkansas Code § 14-47-140(d), concerning special elections
 24 for mayor, is amended to read as follows:

25 (d) The special election shall be held ~~not less than thirty (30) days~~

 27 next special election date under § 7-11-304.

 29 SECTION 14. Arkansas Code § 14-48-104(b), concerning special elections

 33 greater than fifteen percent (15%) of the aggregate number of votes cast, as
 34 prescribed, the Secretary of State shall call the election by proclamation ~~in~~

3 SECTION 15. Arkansas Code § 14-57-704(a), concerning special elections
4 for the levy of a vehicle tax, is amended to read as follows:

7 vehicle owners residing in the city or town may be collected, the mayor shall

27 drainage districts where the boundaries of the districts embrace all of the

 36 shall be held, ~~on a day to be designated by the county board of election~~

25 SECTION 23. Arkansas Code § 14-386-403(a), concerning elections on
26 enclosures in fencing districts, is amended to read as follows:

27 (a) The county court shall in the same publication prescribed by § 14-
28 386-402 give notice of and cause an election to be held ~~within thirty (30)~~
29 ~~days of the date of~~ on the next special election date under § 7-11-304 after
30 the filing of the petition, in the townships or parts of townships included

11 SECTION 28. Arkansas Code § 26-74-207 is amended to read as follows:
12 26-74-207. Call for tax election.

13 (a)(1) A county quorum court may call an election for the levy of a
14 countywide sales and use tax in the amount of:

- 15 (A) One-eighth of one percent (0.125%);
- 16 (B) One-fourth of one percent (0.25%);
- 17 (C) One-half of one percent (0.50%);
- 18 (D) Three-fourths of one percent (0.75%);
- 19 (E) One percent (1%); or
- 20 (F) Any combination of these amounts.

21 (2) The election shall be held ~~within one hundred twenty (120)~~
22 ~~days of the ordinance calling the election~~ under § 7-11-201 et seq.

23 (3) Each tax shall be adopted by ordinance and with approval of
24 the voters of the county in accordance with this subchapter.

25 (b)(1) If a petition is filed requesting an election on the question
26 of the levy of the tax authorized under this subchapter, the quorum court
27 shall submit the question of the levying of the tax to the electors.

28 (2) The petition must be signed by a number of the legal voters
29 in the county that shall be no less than fifteen percent (15%) of the number
30 of votes cast for the office of circuit clerk at the last preceding general
31 election.

32 (3) The election shall be held ~~within one hundred twenty (120)~~
33 ~~days of the filing of the petition~~ under § 7-11-201 et seq.

34 (c) The county quorum court shall notify its county board of election
35 commissioners that the measure has been referred to the vote of the people
36 and shall submit a copy of the ballot title to the county board of election

1 commissioners.

3 SECTION 29. Arkansas Code § 26-74-307(a), concerning an election to
4 levy a countywide sales tax, is amended to read as follows:

6 (a)(1) A county quorum court may call an election for the levy of a
7 countywide sales tax in an amount of:

8 (A) One-eighth of one percent (0.125%);

9 (B) One-fourth of one percent (0.25%);

10 (C) One-half of one percent (0.5%);

11 (D) Three-fourths of one percent (0.75%);

12 (E) One percent (1%); or

13 (F) Any combination of these amounts.

14 (2) The election shall be held ~~within one hundred twenty (120) days of~~
