1 THAT the following is proposed as an amendment to the Constitution of 2 the State of Arkansas, and upon being submitted to the electors of the state 3 for approval or rejection at the next general election for Representatives 4 and Senators, if a majority of the electors voting thereon at the election 5 adopt the amendment, the amendment shall become a part of the Constitution of 6 the State of Arkansas, to wit:

8 SECTION 1. Section 1 of Amendment 42 to the Constitution of the State 9 of Arkansas is amended to read as follows:

10

1. Commission created - Members - Powers.

11 There is hereby created a State Highway Commission which shall be 12 vested with all the powers and duties now or hereafter imposed by law for the 13 administration of the State Highway Department, together with all powers 14 necessary or proper to enable the Commission or any of its officers or 15 employees to carry out fully and effectively the regulations and laws 16 relating to the State Highway Department which shall have the powers and 17 duties as are now or may hereafter be prescribed by the General Assembly. 18

19 SECTION 2. Section 2 of Amendment 42 to the Constitution of the State 20 of Arkansas is amended to read as follows:

21 § 2. Qualifications and appointment of members - Terms of office of 22 first commission.

23 Within ten days after the convening of the General Assembly of the 24 State of Arkansas in the year 1953, the Governor, by and with the advice and 25 consent of the Senate, shall appoint five persons who are qualified electors 26 of the State to constitute the State Highway Commission for terms of two, four, six, eight and ten years respectively. The terms of the persons so 27 28 appointed shall be determined by lot. The Commissioners to be appointed from 29 the State at large; provided, however, that no two Commissioners shall be 30 appointed from any single Congressional District.

In the event of rejection by the Senate of a person whose name has been so submitted, the Governor shall within five days after receipt of written notice from the Secretary of the Senate of such rejection submit the name of another appointee to fill such vacancy. In the event the Governor should within five days thereafter fail to appoint or fail to submit to the Senate for confirmation the name of any person to be appointed, the Senate shall

| 19 | State of Arkansas shall be eligible to be elected to the commission from the |
| 20 | state at large. |
| 21 | (C) The member elected from the state at large shall serve |
| 22 | as chair of the commission. |
| 23 | (d) The members of the State Highway Commission shall be elected by |
| 24 | plurality vote and on a nonpartisan basis at the general election next |
| 25 | following the adoption of this amendment. |
| 26 | (e) The General Assembly shall enact laws establishing procedures for |
| 27 | the nonpartisan election of commissioners. |
| 28 | (f)(1) The initially elected members shall draw lots for terms so that |
| 29 | three (3) members shall serve a four-year term and two (2) members shall |
| 30 | <u>serve a two-year term.</u> |
| 31 | (2) Successors shall serve four-year terms. |
| 32 | (g) The elected members of the commission shall take office on the |
| 33 | first Monday of January in the year immediately following the date of their |
| 34 | election. |
| 35 | (h)(l) Except as provided in subdivision (h)(2) of this section, no |
| 36 | person shall serve as a member of the commission for more than two (2) four- |

| 13 | SECTION 3. Section 3 of Amendment 42 to the Constitution of the State |
| 14 | of Arkansas is amended to read as follows: |
| 15 | § 3. Terms of office of members Compensation and expenses of members. |
| 16 | Upon the expiration of the foregoing terms of said Commissioners, a |
| 17 | successor shall be appointed by the Governor in the manner provided for in |
| 18 | Section 2 for a term of ten years, which term shall thereafter be for each |
| 19 | member of the Commission. |
| 20 | (a) The General Assembly shall by law determine the amount and method |
| 21 | of payment of compensation, if any, and expenses of the members of the State |
| 22 | Highway Commission. |
| 23 | (b) The compensation and expenses of commissioners may be increased |
| 24 | but not diminished during the term for which they are elected. |
| 25 | (c) The compensation of all commissioners shall be equal. |
| 26 | |
| 27 | SECTION 4. Section 4 of Amendment 42 to the Constitution of the State |
| 28 | of Arkansas is amended to read as follows: |
| 29 | § 4. Removal of members — Hearing - Review and appeal. |
| 30 | A Commissioner may be removed by the Covernor only for the same causes |
| 31 | as apply to other constitutional officers after a hearing which may be |
| 32 | reviewed by the Chancery Court for the First District with right of appeal |
| 33 | therefrom to the Supreme Court, such review and appeal to be without |
| 34 | presumption in favor of any finding by the Governor or the trial court, and |
| 35 | provided further, in addition to the right of confirmation hereinabove |
| 36 | reserved to the Senate, the Senate may upon the written request of at least |

| 19 | the request of the Governor and shall be heard in the circuit court for the |
| 20 | county in which that commissioner resides. |

| 22 | SECTION 5. Section 6 of Amendment 42 to the Constitution of the State |
| 23 | of Arkansas is amended to read as follows: |
| 24 | § 6. Director of Highways Arkansas State Highway and Transportation |
| 25 | Department. |
| 26 | The Commission shall appoint a Director of Highways who shall have such |
| 27 | duties as may be preseribed by the Commission or by statute. |
| 28 | (a) There is created the position of Director of the Arkansas State |
| 29 | Highway and Transportation Department. |
| 30 | (b) The director shall be appointed by the Governor for a term of four |
| 31 | (4) years and may be removed by the Governor during his or her term only with |
| 32 | the approval by a majority vote of the total number of commissioners. |
| 33 | (c) The director may be reappointed at the pleasure of the Governor. |
| 34 | |
| 35 | SECTION 6. Amendment 42 to the Constitution of the State of Arkansas |
| 36 | is amended to add a new Section 7 to read as follows: |

| 1 | § 7. Officers and Duties. |

| 7 | SECTION 7. Effective Date - Transition. |
| 8 | (a) The provisions of this amendment shall be effective immediately |
| 9 | upon its adoption by the qualified electors of the state. |
| 10 | (b) The members of the State Highway Commission serving on the |
| 11 | effective date of this amendment shall continue to serve in their respective |
| 12 | positions and shall have the powers, duties, and obligations prescribed under |
| 13 | Amendment 42 of the Arkansas Constitution until the newly elected members of |
| 14 | the commission take office under the provisions of this amendment. |
