20	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL

22	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:

24	THAT the following is proposed as an amendment to the Constitution of
25	the State of Arkansas, and upon being submitted to the electors of the state
26	for approval or rejection at the next general election for Representatives
27	and Senators, if a majority of the electors voting thereon at the election
28	adopt the amendment, the amendment shall become a part of the Constitution of
29	the State of Arkansas, to wit:

31	SECTION 1. Section 2 of Amendment 55 of the Arkansas Constitution,
32	concerning powers of the quorum court, is amended to add a new subsection to

34	(c)(1)(A) The Quorum Court may refer to the voters of the county the
35	question of whether to abolish all township offices of constable in the
36	county at a general election.



1	(B) The Quorum Court may refer the question under
2	subdivision (c)(l)(A) of this section upon approval by a majority of the
3	members of the Quorum Court.
4	(2) If a majority of those voting on the question at a general
5	election approve the abolishing of all township offices of constable in the
6	county, each township office of constable in the county shall be abolished at
7	the end of the existing term for which the constable was elected.
8	(3) The authority of the Quorum Court to call an election under
9	subdivision (c)(l) of this section does not establish the position of
10	constable as a county position.
