31	retired from Arkansas Children's Hospital (ACH) in 2001 after spending 26		
32	years of service there	e; and

34	WHEREAS, Dr. Low	ve graduated from U	AMS in Little Rock, Arkansas, and
35	completed a residency at the Children's Medical Center in Boston,		
36	Massachusetts; she then became an instructor at Harvard Medical School; later		

1 she was appointed Chief Resident of Pediatrics at UAMS; and after serving in 2 that capacity, she began her own private practice for 12 years before 3 returning to serve as faculty at UAMS; and 4 5 WHEREAS, Dr. Lowe served Arkansas in numerous capacities including 6 Professor of Pediatrics of UAMS College of Medicine; Medical Director of ACH; 7 and Associate Dean for Children's Affairs of the UAMS College of Medicine; 8 was the first recipient of the Harvey and Bernice Jones Distinguished Chair 9 in Pediatrics; served as President of the American Academy of Pediatrics; and 10 in 2002, was awarded the UAMS Chancellor's Award for distinguished 11 achievements in science and medicine; and 12 13 WHEREAS, there is currently a Betty Ann Lowe M.D. Endowed Chair in 14 Pediatric Education at ACH; and the Betty A. Lowe M.D. award, which is given 15 to an individual who has made a significant contribution to the well-being of 16 children through his or her leadership and service, was established in 2001 17 at Arkansas Children's Hospital in honor of her retirement; and 18 19 WHEREAS, when Dr. Lowe accepted the position of Medical Director at 20 ACH, there were only 45 beds and a handful of doctors and residents to care 21 for its patients; and she helped guide the growth of the institution to 22 become one of the largest pediatric hospitals in the nation; and 23 24 WHEREAS, as stated by Dr. Jonathan Bates, President and CEO of ACH, "We 25 will be eternally grateful to Dr. Lowe, who dedicated her life to the service of the children of Arkansas and to the education of those who serve them. 26 27 She was their advocate, healer, and friend. In fact, she was a friend to us 28 all.
