16 ARKANSAS, AND HIS LOCAL COMMUNITY.

19 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL
20 ASSEMBLY OF THE STATE OF ARKANSAS:

22 *WHEREAS, John Phillip Carroll of Little Rock, Arkansas, died peacefully*
23 *on Saturday, March 9, 2013, at the age of 87 in his own home in the presence*
24 *of his beloved wife Diane; and*

25
26 *WHEREAS, Mr. Carroll was born in Fort Smith, Arkansas, on August 1,*
27 *1925, to Josephine and John Carroll and had one sister JoAnn; he graduated*
28 *from Fort Smith High School in 1943, and a few months after receiving his*
29 *diploma, Mr. Carroll received his notice to join the Army; and*

30
31 *WHEREAS, the years as a soldier never left him; he arrived at the front*
32 *lines in Europe as a 19-year-old Squad Leader, Staff Sergeant, and spent his*
33 *first Christmas Mass in Strasbourg bearing his service rifle; on a bitter*
34 *cold snowy day in January 1945, Mr. Carroll, along with his unit, was*
35 *captured by a German Army panzer division in the Battle of Hatten, which*
36 *occurred just after the Battle of the Bulge; and he was captured and became a*



1 *German prisoner of war in Stalag IV-B until the war's end; and*

3 *WHEREAS, after returning from the war, Mr. Carroll attended the*
4 *University of Arkansas where he completed his degree and earned a law degree*
5 *on the GI Bill; he was a member of the Kappa Sigma and Delta Theta Phi*
6 *fraternities; only 3 months after gaining a job with the Rose Law Firm in*
7 *Little Rock, Arkansas, he was called back to duty for the Korean War, but*
8 *fate and friendship shined upon him; and his best friend, Jack Deacon, who*
9 *was serving in the Pentagon, asked Mr. Carroll to join him in Washington,*
10 *D.C.; and*
11

12 *WHEREAS, aside from his roles as a husband, father, and grandfather,*
13 *Mr. Carroll's most prized role was as a member of the Rose Law Firm; he*
14 *joined the firm in 1950, which was then known as Rose, Meek, House, Barron*
15 *and Nash; over the course of 63 years in practice, Mr. Carroll remained with*
16 *the same firm, the oldest law firm on this side of the Mississippi River; and*
17 *he believed that he practiced under and with some of the finest lawyers to*
18 *ever practice in the State of Arkansas; and*

20 *WHEREAS, he was a lifelong member of the Pulaski County Bar Association*
21 *and served as its president in 1967 and received the Lawyer Award in 1980; he*
22 *was also active in the Arkansas Bar Association serving as its president in*
23 *1980-81, Foundation President in 1969, and Chairman of the Executive*
24 *Committee; he earned numerous awards throughout his career, including the*
25 *C.E. Ransick Award of Excellence, the Ike Scott Fellow Award, the Outstanding*
26 *Lawyer of Arkansas Award, and the University of Arkansas Outstanding Alumnus*
27 *Award; he was a Fellow of the American Bar Foundation, Fellow of the American*
28 *College of Trial Lawyers, Fellow of the International Academy of Trial*
29 *Lawyers, and a Member of the House of Delegates of the American Bar*
30 *Association representing the Uniform Law Commission; and*
31

32 *WHEREAS, for most of his long career, Mr. Carroll served as a Uniform*
33 *Law Commissioner on behalf of Arkansas, serving as president of the Uniform*
34 *Law Commission from 1985 to 1987; he became a Life Member in 1989 and*
35 *received the organization's Lifetime Achievement Award; and the Uniform Law*
36 *Commission is the national organization that is responsible for studying and*

1 *developing the uniform laws adopted by the 50 states to govern issues from*
2 *commercial law to family law; and*

3
4 *WHEREAS, Mr. Carroll was a charter member and Secretary of the Arkansas*
5 *Supreme Court Jury Instruction Committee that developed the pattern*
6 *instructions used by juries throughout the state today; he served as a*
7 *Special Chief Justice of the Arkansas Supreme Court in 1979, taught Evidence*
8 *and Trial Practice at the University of Arkansas at Little Rock William H.*
9 *Bowen School of Law in Little Rock, and taught Communications Law at the*
10 *University of Arkansas at Little Rock; he was a Charter Barrister in the*
11 *William R. Overton Chapter of Inns of Court; and his devotion to practice and*
12 *the Rose Law Firm ended only with his life, as he maintained a daily schedule*
13 *at the firm until his death earlier this month; and*

14
15 *WHEREAS, Mr. Carroll was a lifelong Catholic whose faith in the church*
16 *never wavered; he attended Holy Souls Parish in Little Rock for more than 59*
17 *years serving as a lector, President of the Parish Council, President of the*
18 *Little Rock Serra Club, President of the St. Thomas More Society, and*
19 *President of the Allen School for Exceptional Children; and he was active in*
20 *the Little Rock community serving as President of the National Conference on*
21 *Christians and Jews, and the Health and Welfare Council of Pulaski County;*
22 *and*

24 *WHEREAS, the gleam in his eyes was reserved for one, his wife Diane, to*
25 *whom he was married for almost 60 years; they met at a very young age and Mr.*
26 *Carroll followed this beautiful Braniff flight attendant by car from airport*
27 *to airport until she married him; they have been friends always, and the two*
28 *of them together were warmth and light; the pair had 3 daughters, Becky*
29 *Carroll (Linda Spink) of Washington, D.C.; Susan Minshall (Bob) of Dallas,*
30 *Texas; and Elizabeth Bradbury (Jim) of Austin, Texas; and grandchildren,*
31 *Margaret Payne (Trey), Grace and Ellen Minshall, and Sam and Jack Bradbury,*
