22	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL
23	ASSEMBLY OF THE STATE OF ARKANSAS:

25	WHEREAS, Homes for Our Troops is a national, nonprofit, nonpartisan
26	organization committed to helping veterans who have selflessly given to our
27	country and have returned home with serious disabilities and injuries; and

29	WHEREAS, Homes for Our Troops assists severely injured veterans and
30	their immediate families by raising donations of money, building materials,
31	and professional labor, and by coordinating the process of building homes
32	that provide maximum freedom of movement and the ability for injured veterans
33	to live more independently; and

35	WHEREAS, the homes provided by Homes for Our Troops are given at no
36	cost to the veterans served by Homes for Our Troops; and

2	WHEREAS, Homes for Our Troops is one of the highest rated military and
3	veterans charities as rated by Charity Navigator and the Better Business
4	Bureau Wise Giving Alliance; and

6	WHEREAS, in addition to numerous other veterans throughout the United
7	States, Homes for Our Troops has selected two Arkansans to receive homes:
8	Marine Sergeant Marshall Kennedy who lost both of his legs and suffered
9	severe damage to his left arm after stepping on an improvised explosive
10	device in Sangin, Afghanistan, on June 13, 2011; and Army Sergeant Marco
11	Robledo who was left a double amputee after an improvised explosive device
12	explosion in Taji, Iraq, in May, 2007,
13	
14	NOW THEREFORE,
15	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES FOR THE EIGHTY-NINTH GENERAL
16	ASSEMBLY OF THE STATE OF ARKANSAS:

18	THAT the House of Representatives expresses sincere appreciation to
19	Homes for Our Troops for helping injured and disabled veterans transition to
20	civilian life by providing specially adapted, barrier-free homes, and
21	commends Homes for Our Troops for its outstanding contributions in bettering
22	the lives of wounded veterans and their families.
