17	WHEREAS, Arkansas State Game and Fish Commission wildlife officer	
18	Michael Neal was presented the Medal of Valor by Vice President Joe Biden at	-
19	a White House ceremony on February 20, 2013, for his heroic acts on May 20,	
20	2010, in West Memphis, Arkansas; and	
21		
22	WHEREAS, on May 20, 2010, 2 West Memphis police officers were killed	
23	during a traffic stop on Interstate 40 after stopping a van driven by 45-	
24	year-old Jerry Kane, who had his 16-year-old son Joseph with him; and	
25		
26	WHEREAS, Officer Neal strapped on his heavy armor, loaded his	
27	Bushmaster M4 .223-caliber rifle, and headed to the scene; and	
28		
29	WHEREAS, the gunmen had made their way to a Wal-Mart parking lot and	
30	were approached by 2 more officers who were subsequently <i>struck</i> by the Kanes	;;

33	WHEREAS, Officer Neal pulled into the parking lot where the Kanes were	ì
34	trying to get away from authorities in their van, and with one hand on the	
35	steering wheel and the other on his rifle, rammed his truck into the van and	l
36	stopped it; and

1 2 WHEREAS, 12 officers fired at the vehicle, killing both Jerry Kane and 3 Joseph Kane; and 4 5 WHEREAS, Officer Neal has received more than two dozen awards since the 6 incident; and 7 8 WHEREAS, Arkansas State Game and Fish Commission Chief of Enforcement 9 Mr. Jeff Crow said, "We are very proud of Michael and appreciate the 10 administration's acknowledgement of his bravery and the valor he displayed in 11 this incident. His extraordinary service is a testament to the dedication of 12 all those who serve in law enforcement in the State of Arkansas."; and 13 14 WHEREAS, United States Senator Mark Pryor noted that Officer Neal 15 showed "extraordinary bravery when he put his life on the line...He is a true 16 hero, and I can think of no one more deserving of this great honor.", 17 18 19 NOW THEREFORE, 20 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL 21 ASSEMBLY OF THE STATE OF ARKANSAS: 22 23 THAT the House of Representatives commends Officer Michael Neal on his 24 extraordinary service to the State of Arkansas and his selection as a 25 recipient of the Medal of Valor. 26 27 BE IT FURTHER RESOLVED THAT upon adoption of this resolution, an appropriate 28 copy shall be provided to Officer Neal by the Chief Clerk of the House of 29 Representatives. 30 /s/Catlett 31 32 33 34 35
