20	WHEREAS, the Eighty-third General Assembly of the State of Arkansas
21	provided money from the tobacco Master Settlement Agreement to fund a
22	statewide program of specialized health care services for seniors living in
23	rural Arkansas; and
24	
25	WHEREAS, the Arkansas Aging Initiative, a program of the Donald W.
26	Reynolds Institute on Aging, University of Arkansas for Medical Sciences,
27	formed partnerships with local and regional hospitals, area health education
28	centers, the area agencies on aging, the Division of Aging and Adult Services
29	of the Department of Human Services, local communities, and colleges and
30	universities; and
31	
32	WHEREAS, the Arkansas Aging Initiative, using these partnerships,
33	established the comprehensive regional centers on aging: Delta Center on
34	Aging (West Memphis), South Arkansas Center on Aging (El Dorado), West
35	Central Center on Aging (Fort Smith), Center on Aging - Northeast
36	(Jonesboro), South Central Center on Aging (Pine Bluff), Schmieding Center

for Senior Health and Education (Springdale), Texarkana Regional Center on 1 2 Aging (Texarkana), Oaklawn Senior Health Care Center (Hot Springs), and Mruk 3 Family Center on Aging (Mountain Home); and 4 5 WHEREAS, the Arkansas Aging Initiative designed a model program to 6 deliver specialized interprofessional geriatric healthcare and education 7 programs to senior citizens residing in rural Arkansas; and 8 9 WHEREAS, the Arkansas Aging Initiative has become a national model and 10 is being replicated in the State of Oklahoma with a grant from the Donald W. 11 Reynolds Foundation; and 12 13 WHEREAS, the Arkansas Aging Initiative continues to address the needs 14 of seniors by using a grant from the Donald W. Reynolds Foundation to 15 replicate the Schmieding Home Caregiver Program at other regional centers on 16 aging for family members and persons needing specialized training to care for 17 seniors; and 18 19 WHEREAS, the Arkansas Aging Initiative provides specialized 20 interprofessional geriatric healthcare and education programs through a 21 network of comprehensive regional centers on aging within sixty (60) miles of 22 every Arkansas senior, 23 24 NOW THEREFORE, 25 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL 26 ASSEMBLY OF THE STATE OF ARKANSAS: 27 28 THAT the House of Representatives recognizes and commends Dr. Claudia 29 Beverly and the Arkansas Aging Initiative leadership team for their efforts 30 in designing, implementing, and operating the comprehensive program of 31 specialized health services for our senior citizens and their families. 32 33 BE IT FURTHER RESOLVED THAT the House of Representatives commends the 34 participating hospital administrators, geriatricians, nurses, educators, and 35 other members of the health profession teams working in these rural areas for 36 their commitment and devotion to improving the quality of life for older
