20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Arkansas Supreme Court for the 2013-2014 fiscal year, the following
24 maximum number of regular employees.

23 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 24 the Arkansas Supreme Court for the 2013-2014 fiscal year, the following
 25 maximum number of part-time or temporary employees, to be known as "Extra
 26 Help", payable from funds appropriated herein for such purposes: five (5)
 27 temporary or part-time employees, when needed, at rates of pay not to exceed
 28 those provided in the Uniform Classification and Compensation Act, or its
 29 successor, or this act for the appropriate classification.

30

31 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 32 to the Arkansas Supreme Court, to be payable from the State Central Services
 33 Fund, for personal services and operating expenses of the Arkansas Supreme
 34 Court for the fiscal year ending June 30, 2014, the following:

 26 *hereby authorized, for the Arkansas Supreme Court – Committees/Programs for*
 27 *the 2013-2014 fiscal year, the following maximum number of part-time or*
 28 *temporary employees, to be known as "Extra Help", payable from funds*
 29 *appropriated herein for such purposes: three (3) temporary or part-time*
 30 *employees, when needed, at rates of pay not to exceed those provided in the*
 31 *Uniform Classification and Compensation Act, or its successor, or this act*
 32 *for the appropriate classification.*

34 *SECTION 7. APPROPRIATION – SUPREME COURT COMMITTEES/PROGRAMS. There is*
 35 *hereby appropriated, to the Arkansas Supreme Court, to be payable from cash*
 36 *funds as defined by Arkansas Code 19-4-801 of the Arkansas Supreme Court, for*

1 *personal services and operating expenses of the Arkansas Supreme Court -*
 2 *Office of Professional Programs, Committee on Professional Conduct, Arkansas*
 3 *Judges and Lawyers Assistance Program, Arkansas Court Automation Project and*
 4 *Arkansas Access to Justice Commission for the fiscal year ending June 30,*

 20 *SECTION 8. Special Language. Arkansas Code Title 16, Chapter 11,*
 21 *Subchapter 1, is amended to add an additional section to read as follows:*
 22 *16-11-116. Supreme Court Committee and Program Employees.*

23 *(a) On July 1, 2013, employees of the following entities or programs,*
 24 *or their successor entities or programs, shall be employees of the State of*
 25 *Arkansas administered by the Arkansas Supreme Court:*

- 26 *(1) Office of Professional Programs;*
 27 *(2) Committee on Professional Conduct;*
 28 *(3) Arkansas Judges and Lawyers Assistance Program;*
 29 *(4) Arkansas Court Automation Project; and*
 30 *(5) Arkansas Access to Justice Commission.*

31 *(b) All employees of an entity or program listed under subsection (a)*
 32 *of this section on July 1, 2013, and thereafter, whose position and salary is*
 33 *established and appropriated by the General Assembly:*

34 *(1) Notwithstanding A.C.A 19-4-801 or any other law to the*
 35 *contrary, employees shall be paid from cash funds of the Arkansas Supreme*
 36 *Court derived solely from revenues received from attorney licensure fees and*

1 any other fees, fines, interest income and charges that may be deposited in
2 the Bar of Arkansas Fund, as determined by the court; and

3 (2) Shall participate in the Arkansas Public Employees'
4 Retirement System.

5 (c) (1) Employees in the Arkansas Public Employees' Retirement
6 System under subdivision (b)(2) of this section may purchase credit for all:

7 (A) Eligible employment; and

8 (B) Employment by an entity listed in subsection (a) of
9 this section.

10 (2) Credit under subdivision (c)(1) of this section may be
11 purchased on behalf of the employee by using retirement funds established for
12 the employee by the Supreme Court.

13
14 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
15 authorized by this act shall be limited to the appropriation for such agency
16 and funds made available by law for the support of such appropriations; and
17 the restrictions of the State Procurement Law, the General Accounting and
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
19 Procedures and Restrictions Act, or their successors, and other fiscal
20 control laws of this State, where applicable, and regulations promulgated by
21 the Department of Finance and Administration, as authorized by law, shall be
22 strictly complied with in disbursement of said funds.

23
24 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General
25 Assembly that any funds disbursed under the authority of the appropriations
26 contained in this act shall be in compliance with the stated reasons for
27 which this act was adopted, as evidenced by the Agency Requests, Executive
28 Recommendations and Legislative Recommendations contained in the budget
29 manuals prepared by the Department of Finance and Administration, letters, or
30 summarized oral testimony in the official minutes of the Arkansas Legislative
31 Council or Joint Budget Committee which relate to its passage and adoption.

32
33 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the
34 General Assembly, that the Constitution of the State of Arkansas prohibits
35 the appropriation of funds for more than a one (1) year period; that the
36 effectiveness of this Act on July 1, 2013 is essential to the operation of

1 the agency for which the appropriations in this Act are provided, and that in
2 the event of an extension of the legislative session, the delay in the
3 effective date of this Act beyond July 1, 2013 could work irreparable harm
4 upon the proper administration and provision of essential governmental
5 programs. Therefore, an emergency is hereby declared to exist and this Act
6 being necessary for the immediate preservation of the public peace, health
7 and safety shall be in full force and effect from and after July 1, 2013.
