3	at the time of the accident was operating or using a motor vehicle while		
4	under the influence of alcohol or drugs in violation of a law relating to the		
5	illegal operation or use of a motor vehicle while under the influence of		
6	alcohol or drugs, and the motorist:		
7	(A) Was convicted of or pleaded guilty or nolo contendere		
8	to the violation of law; or		
9	(B) Dies as a result of the accident if it is proven by a		
10	preponderance of the evidence that the motorist was operating or using the		
11	motor vehicle while under the influence of alcohol or drugs in violation of a		
12	law relating to the illegal operation or use of a motor vehicle while under		
13	the influence of alcohol or drugs;		
14	(2) If the plaintiff or claimant was a passenger in a motor		
15	vehicle involved in the accident, unless the plaintiff or claimant is an
