1 circumstances surrounding the abandoned ballot; and 2 (D) Preserve the abandoned ballot separately. 3 (2) The county board of election commissioners shall not count 4 the ballot. 5 (h)(l) If a paper ballot that is fed by a voter or the voter's 6 authorized assistant into an electronic vote tabulating device at the polling 7 site is rejected by the device but is still in the receiving part of the 8 counter and the voter has not reported to a poll worker his or her desire to 9 cancel or replace the ballot before departing the polling site, two (2) poll workers shall take action to override warnings on the device and complete the 10 11 process of casting the ballot. 12 (2) The poll workers shall document: 13 (A) The time: 14 (B) The name of the voter; 15 (C) The names of the poll workers completing the process of 16 casting the ballot; and 17 (D) All other circumstances surrounding the abandoned ballot. 18 19 20 SECTION 2. Arkansas Code § 7-5-310 is amended to read as follows: 21 7-5-310. Privacy - Assistance to disabled voters. 22 (a) Each voter shall be provided the privacy to mark his or her ballot. 23 Privacy shall be provided by the poll workers at each polling site or by the 24 county clerk, if the county clerk conducts early voting, to ensure that a 25 voter desiring privacy is not singled out. 26 (b)(1) A voter shall inform the poll workers at the time that the voter 27 presents himself or herself to vote that he or she is unable to mark or cast 28 the ballot without help and needs assistance in casting his or her ballot. 29 (2) The voter shall be directed to a voting machine equipped for use by persons with disabilities by which he or she may elect to cast his or 30 31 her ballot without assistance, or the voter may request assistance with either the paper ballot or the voting machine, depending on the voting system 32 in use for the election, by: 33 (A) Two (2) poll workers; or 34 35 (B) A person named by the voter. 36 (3) If the voter is assisted by two (2) poll workers, one (1) of

I UNDERSTAND THAT UNLESS I AM A POLL WORKER, COUNTY CLERK, OR DEPUTY CLERK I CANNOT PROVIDE ASSISTANCE TO MORE 24 25 THAN SIX (6) VOTERS. I UNDERSTAND THAT IF I PROVIDE FALSE INFORMATION ON THIS 26 REGISTER, I MAY BE GUILTY OF PERJURY AND SUBJECT TO A FINE OF UP TO TEN 27 THOUSAND DOLLARS (\$10,000) OR IMPRISONMENT FOR UP TO TEN (10) YEARS, OR <u>BOTH</u>."; 28 29 (ii) The printed name of the voter being assisted; 30 (iii) The printed name and address of the person 31 providing the assistance; and 32 (iv) The signature of the person providing the 33 assistance. 34 (C) A person shall not approach a voter and offer 35 assistance to cast a ballot if the voter is: 36 (i) In the polling site or early voting location;

3	(iii) Within one hundred feet (100') of the primary
4	entrance to the polling site or early voting location.
5	(c) Any If a voter who informs a poll worker or county clerk at a

7	line for extended periods of time because of physical, sensory, or other
8	disability <del>who presents himself or herself for voting and who then informs a</del>
9	poll worker at the polling site that he or she is unable to stand in line for
10	extended periods of time shall be entitled to and assisted by a poll worker
11	the poll worker or county clerk shall allow and assist the voter to advance
12	to the head of <del>any</del> <u>the</u> line of voters then waiting in line to vote at the
13	polling site <u>or early voting location</u> .

17	(a)(l) A designated bearer may obtain absentee ballots <del>from the county</del>
18	<del>elerk</del> for <del>not</del> <u>no</u> more than two (2) voters <u>per election</u> .
19	(2)(A) A <del>t no time shall a</del> <u>A</u> designated bearer <u>shall not</u> have
20	more than two (2) absentee ballots in his or her possession <u>at any time</u> .
21	(B) If the county clerk knows or reasonably suspects that
22	a designated bearer has more than two (2) absentee ballots in his or her
23	possession, the county clerk shall notify the prosecuting attorney.
24	(3)(A) A designated bearer receiving an absentee ballot from the
25	county clerk for a voter shall <u>obtain the absentee ballot directly from the</u>
26	<u>county clerk and</u> deliver the absentee ballot directly to the voter.
27	(B) A designated bearer receiving an absentee ballot from
28	a voter shall <u>obtain the absentee ballot directly from the voter and</u> deliver
29	the absentee ballot directly to the county clerk.
30	(4)(A) A designated bearer may deliver to the county clerk the
31	absentee ballots for not more than two (2) voters.

33	statement accompanying the absentee ballot.

36	photographic identification to the county clerk;

ballots to the county clerk and obtain absentee ballots from the county clerk 1 2 for not more than two (2) voters per election who cannot cast a ballot at the 3 appropriate polling place on election day because the voter is a patient in a 4 hospital or long-term care or residential care facility licensed by the 5 state. 6 (2) At no time shall an authorized agent have more than two (2) 7 absentee ballots in his or her possession. 8 (3)(A) An authorized agent receiving an absentee ballot from the 9 county clerk for a voter shall deliver the absentee ballot directly to the 10 voter. 11 (B) An authorized agent receiving an absentee ballot from a 12 voter shall deliver the absentee ballot directly to the county clerk. 13 (4) (A) In order for an authorized agent to obtain a ballot from 14 the county clerk, the authorized agent shall submit to the county clerk an 15 affidavit from the administrative head of a hospital or long-term care or 16 residential care facility licensed by the state that the applicant is a 17 patient of the hospital or long-term care or residential care facility 18 licensed by the state and is thereby unable to vote on the election day at 19 his or her regular polling site. 20 (B) A copy of the affidavit shall be retained by the 21 county clerk as an attachment to the application for an absentee ballot. 22 (5) In order to obtain an absentee ballot from the county clerk, 23 the: 24 (A) Authorized agent shall present current photographic 25 identification to the clerk; 26 (B) Clerk shall print the authorized agent's name and 27 address beside the voter's name on a register; and (C) Authorized agent shall sign the register under oath 28 29 indicating receipt of the voter's ballot. 30 (6) Upon delivering When an authorized agent delivers an 31 absentee ballot to the county clerk, the: 32 (A) Authorized agent shall show some form of current 33 photographic identification to the clerk; 34 (B) Clerk shall print the authorized agent's name and 35 address beside the voter's name on a register; and 36 (C) Authorized agent shall sign the register under oath

13	contain the following oath on each page: " <u>I ACKNOWLEDGE THAT ARKANSAS LAW</u>
14	PROHIBITS DESIGNATED BEARERS AND AUTHORIZED AGENTS FROM RECEIVING OR
15	RETURNING MORE THAN TWO (2) ABSENTEE BALLOTS PER ELECTION. I HAVE COMPLIED
16	<u>WITH THE ARKANSAS LAW.</u> IF YOU I UNDERSTAND THAT IF I PROVIDE FALSE

20	(d)(1)(A) An administrator may deliver to the county clerk an
21	application for an absentee ballot for any voter who is a patient of a long-
22	term care or residential care facility licensed by the state and who <del>names</del>
23	<u>authorizes</u> the administrator <del>on his or her application as the administrator</del>
24	<del>of the facility where the voter resides</del> <u>to obtain an absentee ballot on his</u>
25	<u>or her behalf</u> .
26	(B) The absentee ballot application shall identify the
27	administrator by name as the administrator of the facility where the voter
28	<u>resides.</u>
29	(2) An Upon presentation of photographic identification to the
30	<u>county clerk, an</u> administrator may receive absentee ballots for as many
31	qualified residents of the facility as apply:
32	(A) Apply for absentee ballots upon presentation of
33	photographic identification to the county clerk; and
34	(B) Identify the administrator in the voter's absentee

17	and write the administrator's name on the voter's absentee ballot return
18	<u>envelope.</u>
19	(e) Any person who knowingly makes a false statement on an affidavit
20	required by this section shall be guilty of perjury and subject to a fine of
21	up to ten thousand dollars (\$10,000) or imprisonment of up to ten (10) years.

23	SECTION 4. Arkansas Code § 7-5-404 is amended to read as follows:
24	7-5-404. Applications for ballots.
25	(a)(1)(A) Applications for absentee ballots must be signed by the
26	applicant and verified by the county clerk by checking the voter's name,
27	address, date of birth, and signature from the registration records <del>or, if</del>
28	unless the application is sent by electronic means.
29	(B) If the application is sent by electronic means, the
30	application must bear a verifiable facsimile of the applicant's signature.
31	(2)(A) If the signatures on the absentee ballot application and
32	the voter registration record are not similar, the county clerk shall not
33	provide an absentee ballot to the voter.
34	(B) If the absentee ballot request is rejected under
35	subdivision (a)(2)(A) of this section, the county clerk shall:
36	(i) Provide notice promptly to the voter of the

2	(ii) Allow the voter to resubmit the request; and
3	(iii) Electronically record the rejection in the
4	permanent system maintained by the county clerk.

18	(ii) Applications by mail must be received in the
19	office of the county clerk of the county of residence of the voter not later
20	than seven (7) days before the election for which the application was made;
21	(iii) A designated bearer may deliver the completed
22	application to the office of the county clerk of the county of residence of
23	the applicant not later than the time the county clerk's office regularly
24	closes on the day before the day of the election;
25	(iv) A person declared as the authorized agent of
26	the applicant may deliver the application to the office of the county clerk
27	of the county of residence of the applicant not later than 1:30 p.m. on the
28	day of the election;
29	(v) An administrator may deliver the application in
30	person at the office of the county clerk of the county of residence of the
31	voter no later than the time the county clerk's office regularly closes on
32	the day before election day; or
33	(vi)(a) Delivery by electronic means to the county
34	clerk's office of the county of residence of the voter not later than seven
35	(7) days before the election for which the application was made.
36	(b) The completed application sent by

1 electronic means will be accepted only upon verification of the facsimile 2 signature of the applicant by the county clerk. 3 (c) Once verified as a reasonable likeness of 4 the voter's signature, the signature appearing on a copy of an application 5 sent by electronic means shall be presumed to be authentic until proven 6 otherwise; or 7 (B) If the applicant does not use the form prescribed in § 8 7-5-405, he or she may make an application for an absentee ballot as follows: 9 (i) A letter or postcard must be received in the 10 office of the county clerk not later than seven (7) days before the date of the election. The letter or postcard shall contain information sufficient for 11 12 the county board of election commissioners and the county clerk to accept the 13 letter or postcard in lieu of the application form; or 14 (ii) An applicant may transmit a written request for 15 an absentee ballot by electronic means that shall contain the voter's 16 signature and other information sufficient for acceptance in lieu of the 17 application form. 18 (b)(1) Any person eligible to vote by absentee ballot may request the 19 county clerk to mail to an address within the continental United States an 20 application for an absentee ballot. 21 (2)(A) For those persons voting by absentee ballot who reside 22 outside the county in which they are registered to vote, the application 23 shall remain in effect for one (1) year unless revoked by the voter, and the 24 county clerk shall thereafter automatically mail, no later than twenty-five 25 (25) days before each election, an absentee ballot for each election. 26 (B)(i) Except for persons of long-term care or residential 27 facilities licensed by the state or other persons who are voters with 28 disabilities as defined in § 7-5-311(d), for For those persons voting by absentee ballot who reside within the county in which they are registered to 29 vote, the application shall be valid for only one (1) election cycle. 30 31 (ii) The election cycle shall include any one (1) 32 election and the corresponding runoff election. 33 (C)(i) For a voter residing in a long-term care or 34 residential facility licensed by the state the application shall remain in 35 effect for one (1) calendar year unless withdrawn by the voter. 36 (ii) The county clerk automatically shall mail, no

11	each election.
12	(c) The following may request an absentee ballot for one (1) or more
13	elections, up to and including the next <del>two (2)</del> regularly scheduled general
14	elections election for federal office, including without limitation any
15	runoff elections that may occur as a result of the outcome of the general
16	elections, by submitting one (1) application during that period of time in
17	the manner provided under subsection (a) of this section:
18	(1) A citizen of the United States temporarily residing outside
19	the territorial limits of the United States;
20	(2) A member of the uniformed services of the United States
